Your Committee on Health, to which was referred H.C.R. No. 69
entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE AUDITOR TO
CONDUCT A SUNRISE REVIEW OF THE REGULATION OF PHARMACY
BENEFIT MANAGEMENT COMPANIES,"

begs leave to report as follows:

The purpose of this concurrent resolution is to move toward
stabilizing health care costs and controlling prescription drug
prices through regulation of pharmacy benefit management
companies. To this end, the Auditor is requested to conduct a
sunrise review of the regulation of pharmacy benefit management
companies, as proposed under H.B. No. 275., and submit a report to
the Legislature at least 20 days prior to the convening of the
2012 Regular Session.


The Department of Commerce and Consumer Affairs testified in
support of this measure.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 69 and
recommends that it be referred to the Committee on Consumer
Protection & Commerce.
