The purpose of this concurrent resolution is to encourage
breastfeeding by new mothers by encouraging the University of
Hawaii John A. Burns School of Medicine (JABSOM) and the School of
Nursing and Dental Hygiene to include breastfeeding in an
education curriculum to educate medical professions to advocate
and promote breastfeeding among expectant and new mothers.


The Hawaii Chapter-American Physical Therapy Association;
Healthy Mothers, Healthy Babies Coalition of Hawaii; and a
concerned individual supported this measure. JABSOM supported the
intent of this measure. The School of Nursing and Dental Hygiene
provided comments.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 7 and
recommends that it be referred to the Committee on Higher
Education.
