"HOUSE RESOLUTION REQUESTING THE DEVELOPMENT AND
IMPLEMENTATION OF A PAIN AND PALLIATIVE CARE POLICY,"

The purpose of this resolution is to increase the quality of
and access to palliative care treatment for acute and chronic pain
patients by requesting the Hawaii State Board of Nursing to
develop and implement a pain and palliative care policy, and
submit a report to the Legislature at least 20 days prior to the
2012 Regular Session.


The Representative of the 38th District, American Cancer
Society, Hawaii Family Forum, St. Francis Healthcare System of
Hawaii, Hawaii Catholic Conference, and Hawaii Chapter of the
American Physical Therapy Association testified in support of this
measure. Hawaii Medical Association offered comments.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee concurs with the intent and purpose of H.R. No. 48 and
recommends that it be referred to the Committee on Finance.


