The purpose of this bill is to incorporate the definitions,
guiding principles, and goals of the Hawaii 2050 Sustainability
Plan into the Hawaii State Planning Act.

The University of Hawaii (UH) System, The Nature Conservancy
of Hawaii, Hawaii Energy Policy Forum, and a concerned individual
supported this bill. The Office of Planning submitted comments.

In light of concerns raised during the public hearing, your
Committees have amended this measure by:

- (1) Requiring UH to submit a report to the Legislature on
the status and progress made in implementing the
sustainability goals set forth by this measure;
- (2) Changing its effective date to July 1, 2112, to
encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for style,
clarity, and consistency.




