S.C.R. No. 91 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING A REVIEW OF THE LAWS  
AND RULES RELATING TO CONFIDENTIALITY, PRIVACY, AND PRIVILEGE  
AND THEIR IMPACT ON JUVENILE INFORMATION SHARING,"

begs leave to report as follows:

The purpose and intent of this measure is to request the  
Department of the Attorney General to review confidentiality laws  
and rules and their impact on juvenile interagency information  
sharing and develop a system of interagency information sharing.

Your Committee received testimony in support of this measure  
from the Department of Human Services, Department of Education,  
and one individual.

Your Committee finds that there is a need for juvenile  
information sharing between justice agencies and other  
governmental entities throughout the State. Your Committee  
further finds that the recommendations the Department of the  
Attorney General would make pursuant to this measure should  
enhance the ability of schools, social service agencies, courts,  
and the juvenile and criminal justice systems to share information  
while safeguarding and protecting the rights of juveniles and  
their families.

As affirmed by the record of votes of the members of your  
Committee on Human Services that is attached to this report, your  
Committee concurs with the intent and purpose of S.C.R. No. 91 and
