<u>SB 140</u> <u>Testimony</u> <u>Status</u>	MAKING A GRANT APPROPRIATION FOR THE HAWAII LIVESTOCK COOPERATIVE. Appropriates funds as a grant to the Hawaii Livestock Cooperative for continuing operations and to help the Hawaii Livestock Cooperative develop a sustainable business plan.	AGL, WAM
<u>SB 1337</u> <u>Testimony</u> <u>Status</u>	RELATING TO LIVESTOCK. Provides a grant pursuant to chapter 42F, HRS, to the Hawaii Livestock Cooperative to enable the cooperative's slaughter facility to stabilize their operations.	AGL, WAM

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.
