<u>HB 1475</u> <u>Status</u>	RELATING TO FARM TO SCHOOL MONTH. Designates October as "Farm to School Month" in Hawai'i.	AGR, HLT
<u>HB 1569</u> <u>Status</u>	RELATING TO AGRICULTURE. Requires the Department of Agriculture to develop and implement an Import Replacement Pilot Program. Effective July, 1, 2011.	AGR, FIN
<u>HB 1570</u> <u>Status</u>	RELATING TO AGRICULTURE. Supports the agricultural industry in Hawaii by helping agricultural businesses meet their feedstock costs.	AGR, FIN
<u>HB 285</u> <u>Status</u>	RELATING TO MEASUREMENT STANDARDS. Establishes the weights and measurements special fund. Requires the board of agriculture to adopt or amend rules to impose or increase fees authorized to be charged under chapter 486, Hawaii Revised Statutes. Makes appropriations.	AGR, FIN

DECISION MAKING TO FOLLOW

- The date and time of the hearing;
- Measure number; and
- The number of copies the Committee is requesting.

While every effort will be made to copy, organize, and collate all testimony received, materials received on the day of the hearing or improperly identified or directed to the incorrect office, may be distributed to the Committee after the hearing.

PAPER: 5 copies (including an original) to Room 424 in the State Capitol;



Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.
