<u>SB 1423</u>	RELATING TO FLOOD INSURANCE. Exempts from insurance code, associations (1) organized before 1880; (2) whose members are active, retired, or honorably discharged members of the U.S. armed forces or sea services; and (3) whose principal purpose is to provide insurance and other benefits to their members. <u>SB 1188</u> <u>Testimony</u> <u>Status</u>	RELATING TO REQUIRED MOTOR VEHICLE POLICY COVERAGE. Amends amounts for liability coverage.	CPN
<u>SB 1189</u> <u>Testimony</u> <u>Status</u>	RELATING TO REQUIRED MOTOR VEHICLE POLICY COVERAGE. Amends amounts for motor vehicle insurance liability coverage.	CPN
<u>SB 1190</u> <u>Testimony</u> <u>Status</u>	RELATING TO AUTOMOBILE PERSONAL INJURY LIMITATIONS. Amends law to require the record reviewer to be of the same specialty as the provider whose treatment is being reviewed and makes the record review available upon request.	CPN

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.

Please note: If you submit your written testimony after 4:00 p.m. the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.
