HB550 HD1 (HSCR743) Testimony Status	RELATING TO TELEVISION. Requires the auditor to analyze the allocation of cable operator franchise fees. Requires a performance review or audit of Olelo Community Television. Appropriation. Effective July 1, 2030. (HB550 HD1)	CPN, WAM
HB845 HD2 (HSCR933) Testimony Status	RELATING TO GROUND LEASES. Within the final ten years of a long-term residential ground lease, permits a lessee to request a lease extension from the lessor. Under specified conditions, requires a lessor to offer to sell the fee simple interest in the land to the lessor for the amount fixed by an appraiser's determination of the leased-fee interest in the land. Establishes a process for arbitration when the lessor and lessee are unable to agree on a rental rate. Effective July 1, 2112. (HB845 HD2)	CPN, JDL
HB1049 HD2 (HSCR824) Testimony Status	RELATING TO INSURANCE. Updates the Insurance Code and related provisions. Effective July 1, 2030. (HB1049 HD2)	CPN, WAM
HB1004 HD1 (HSCR856) Testimony Status	RELATING TO CHAPTER 480, HAWAII REVISED STATUTES. entities to bring an action for damages notwithstanding their status as indirect purchasers. Effective July 1, 2030. (HB1004 HD1)	CPN, JDL
