SB 1285 RELATING TO CAPITAL INVESTMENTS. EDT, WAM

Amends chapter 37, Hawaii Revised Statutes, to include agency-wide **Testimony** technology and computer systems with an estimated useful life of **Status** greater than seven years as capital investments to allow all costs to be financed with bond funds and depreciated as capital investments.

SB 237 RELATING TO CYBERBULLYING. EDT, JDL

Establishes an offense of harassment by cyberbullying, with the first **Testimony** and second offenses as misdemeanors, and any third and subsequent

offense as a class C felony. **Status**

RELATING TO TRESPASS. **SB 1207** EDT, JDL

Holds authors and publishers of visitor websites and publications liable **Testimony** to readers who suffer injury or death as a result of being enticed to

trespass; exempts property owners from liability. **Status**

RELATING TO THE SMALL BUSINESS REGULATORY REVIEW **SB 1498 EDT**

BOARD.

[Measure added on **Testimony** 02-03-11] Requires the Small Business Regulatory Review Board to identify rules that shall be amended or repealed to conform to the repeal or **Status** amendment of related statutes. Directs the board to work with state

> agencies to develop a procedure for expediting the amendment or repeal of rules when the changes are required only to comply with the

repeal or amendment of statutes.
