SB1310 Testimony Status	RELATING TO SECTION 13 OF ACT 380, SESSION LAWS OF HAWAII 1997. Removes the sunset date on the use of new safe harbor agreements, habitat conservation plans, and incidental take licenses as recovery options for conserving and protecting the State's threatened and endangered species.	ENE/WLH, JDL
SB202 Testimony Status	RELATING TO LANDFILLS. Requires public approval from residents within a 1-mile radius for the permitting of a new landfill or the expansion of an existing landfill.	ENE/WLH, JDL
SB688 Testimony Status	RELATING TO ENVIRONMENTAL ASSESSMENTS. Exempts actions involving the construction of or changes or modifications to affordable housing located within areas zoned for residential or commercial use where the activity does not require a rezoning designation or a variance from environmental assessment requirements. SB689 Testimony Status	RELATING TO LAKE WILSON. Establishes a pilot project within the department of land and natural resources to demonstrate the effectiveness of marine phytoremediation using plants that are native to Hawaii to remove pollutants and improve water clarity in Lake Wilson; appropriates funds for the project.
