RELATING TO OUT-OF-STATE OFFICES.
Beginning 7/1/11, requires the auditor to conduct at least every two years a management and financial audit of the department of business, economic development, and tourism out-of-state offices. Requires reports to the legislature. Repeals exemption from audit and accounting requirements for out-of-state offices.

Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.


