RELATING TO HIGH TECHNOLOGY.

ERB/WLO, FIN

Requires the Department of Business, Economic Development, and Tourism to work with the department of land and natural resources to identify appropriate lands for a high technology park on Oahu and to consult with the high technology development corporation to plan for the establishment of the high technology park. Makes appropriation.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing with a transmittal cover indicating:

- Testifier's name with position/title and organization;
- The Committee the comments are directed to;
- The date and time of the hearing;
- Measure number; and
- The number of copies the Committee is requesting.




Testimony submitted will be placed on the Legislative Web site after the hearing adjourns. This public posting of testimony on the Web site should be considered when including personal information in your testimony.
