RELATING TO SHIPBOARD GAMING.

JDL/EDT, WAM

Authorizes shipboard gaming on vessels in state waters. Establishes the Hawaii gaming board within DBEDT, an admission tax and a wagering tax, and a gaming fund for the deposit of fees, taxes, and fines.

**Decision Making to follow, if time permits.**

When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.

**Please note: If you submit your written testimony after 24 hours the day prior to the hearing, please sign-in at the staff table to testify orally. A copy of your testimony may not be available during the hearing but will be posted online for the public after the hearing.**
