SB 1038 RELATING TO EMPLOYMENT SECURITY. JDL, WAM

Testimony Enacts the optional total unemployment rate trigger.

Status

SB 1088 RELATING TO UNEMPLOYMENT INSURANCE BENEFITS. JDL, WAM

Authorizes an individual that is attached to a regular employer that is not offering work to continue to be eligible to receive unemployment insurance benefits even if that individual voluntarily separates from part-time employment, with or without good cause from

a secondary employer during that week.

SB 1089 RELATING TO DISLOCATED WORKERS. JDL

Testimony

Authorizes the department of labor and industrial relations to exercise enforcement powers against an employer in a covered establishment.

Status

Amends the definition of a "covered establishment" subject to chapter

394B, HRS, relating to dislocated workers, to include any business entity that employs at least one person within the previous year.

Decision Making to follow, if time permits.
