<u>HB 397, HD1</u> <u>(HSCR30)</u> <u>Status</u>	RELATING TO LANDS CONTROLLED BY THE STATE. Requires more specificity in all concurrent resolutions for the review of proposed exchanges, sales, or gifts of state land, including whether the land was classed as government or crown lands prior to August 15, 1895. Requires a copy of the concurrent resolution be submitted to the Office of Hawaiian Affairs at least three months prior to the appropriate legislative session. (HB397 HD1)	WLO/HAW, JUD, FIN
<u>HB 399</u> <u>(HSCR18)</u> <u>Status</u>	RELATING TO THE PORTION OF INCOME AND PROCEEDS FROM THE LANDS OF THE PUBLIC LAND TRUST FOR USE BY THE OFFICE OF HAWAIIAN AFFAIRS. Requires the transfer of cash or land to OHA as income and proceeds that OHA is to receive from the public trust pursuant to article XII, sections 4 and 6, of the state constitution, for the period from 11/7/1978 to 7/1/2010.	HAW/WLO, JUD, FIN
<u>HB 396</u> <u>(HSCR221)</u> <u>Status</u>	RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS. Requires certain council, board, and commission members to take a training course offered by OHA relating to native Hawaiian traditional and customary rights, natural resource protection and access rights, and the public trust.	HAW, JUD, FIN
<u>HB 1627, HD1</u> <u>(HSCR224)</u> <u>Status</u>	RELATING TO GOVERNMENT. Establishes procedures for state recognition of a first nation government. (HB1627 HD1)	HAW, JUD, FIN

DECISION MAKING TO FOLLOW
