<u>HB 277</u> <u>Status</u>	RELATING TO MILITARY AFFAIRS. Establishes the military affairs liaison trust fund as a separate fund of a nonprofit corporation, to support the nonprofit corporation in its duties as the state liaison in matters relating to the military. Appropriates funds for the trust fund.	PBM, FIN
<u>HB 461</u> <u>Status</u>	RELATING TO THE UNIFORM MILITARY AND OVERSEAS VOTERS ACT. Enacts Uniform Military and Overseas Voters Act to ensure ability of members of the military and others eligible voters who are overseas to participate in all elections for federal, state, and local offices. Authorizes ballots and balloting materials to be transmitted by facsimile or electronic mail.	PBM, JUD, FIN
<u>HB 681</u> <u>Status</u>	RELATING TO THE MILITARY. Allows reservists and national guard members in active service who desire to run for office to file nomination papers and take their oaths by mail.	PBM, JUD
<u>HB 49</u> <u>Status</u>	RELATING TO ARMED FORCES SERVICE MEMBERS. Recognizes the federally prescribed DD Form 93, or its successor form, as an acceptable method of determining the person authorized to direct disposition of an armed forces service member's remains.	PBM, JUD
<u>HB 668</u> <u>Status</u>	RELATING TO VETERANS. Establishes a working group to explore the feasibility of providing specialty license plates for all veterans.	PBM, FIN



<u>HB 1502</u> <u>Status</u>	RELATING TO THE JUNIOR RESERVE OFFICERS' TRAINING CORPS. Appropriates funds for 6 instructor positions for JROTC programs in high schools in the State.	PBM, FIN
<u>HB 1107</u> <u>Status</u>	RELATING TO THE HAWAII NATIONAL GUARD. Authorizes members of the Hawaii national guard to use non-lethal weapons, including electric guns, when assisting civil authorities in disaster relief, civil defense, or law enforcement functions.	PBM, JUD
<u>HB 551</u> <u>Status</u>	RELATING TO ELECTRIC GUNS. Permits county liquor authority investigators to possess electric guns.	PBM, JUD
<u>HB 1000</u> <u>Status</u>	RELATING TO ENHANCED 911 SERVICES. Establishes a single entity to administer enhanced 911 services for the State and expands the membership and responsibilities of the Wireless Enhanced 911 Board.	PBM, CPC, FIN
<u>HB 603</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Establishes a working group within the civil defense agency to create a system for sharing information across public agencies during the preparation and planning for certain events, whether arising naturally or from scheduled events.	PBM, FIN
<u>HB 314</u> <u>Status</u>	RELATING TO DISASTER PREPAREDNESS. Establishes the Office of Disaster Preparedness and a Disaster Preparedness Commission to develop a disaster preparedness plan for the State that includes the identification of natural hazards and impact zones, disaster mitigation policies, incentives, and response plans. Appropriates funds.	PBM, FIN
<u>HB 121</u> <u>Status</u>	MAKING AN APPROPRIATION FOR THE HAWAII CIVIL AIR PATROL. Makes appropriations for the operational expenses of the Hawaii civil air patrol.	PBM, FIN
<u>HB 1012, HD1</u> <u>(HSCR56)</u> <u>Status</u>	RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL. Appropriates funds to the Department of the Attorney General for operating expenses of state law enforcement agencies relating to the planning and operation of security services and activities for the 2011 Asia-Pacific Economic Cooperation Leaders Meeting in Honolulu, Hawaii. Effective July 1, 2022. (HB1012 HD1)	INT, PBM, FIN
<u>HB 1632</u> <u>Status</u>	RELATING TO CEMETERIES. Provides funds for the acquisition of land to expand the veteran's cemetery in Makawao, Maui.	PBM, FIN


