RECONSIDERATION OF PRIOR DECISION

The following measures were previously deferred on Monday, March 21,

SB 1327, SD2 (SSCR672) Status	RELATING TO PASSENGER FACILITY CHARGES. Authorizes the department of transportation to collect increases in passenger facility charges without amending the administrative rule. Effective 07/01/2050. (SD2)	TRN, FIN
SB 1329, SD1 (SSCR683) Status	RELATING TO MOTOR VEHICLE WEIGHT TAX. Allows for increase in the State motor vehicle weight tax and deposits the money into the State Highway Fund. Effective 7/1/2050. (SD1)	TRN, FIN

DECISION MAKING TO FOLLOW
