TO THE HONORABLE ROSALYN H. BAKER, CHAIR, BRIAN T. TANIGUCHI, VICE CHAIR, AND MEMBERS OF THE COMMITTEE:

It is my pleasure to support the nomination of Kealiilalanikulani ("Keali'i") S. Lopez to be Director of Department of Commerce and Consumer Affairs (DCCA).

I have known Keali'i since the 1980s when she was working at Oceanic Cable on community access programming. I have followed her career as she moved to Kamehameha Schools in Distance Learning and then as she came back to 'Olelo ultimately to become its leader. She was also one of the three nominees for the latest Kamehameha Schools Trustee vacancy by a selection committee of which I am a member.

Keali'i's career has been about allowing people to use modern communications specifically television for learning, for sharing stories, and for expressing views. In the case of 'Olelo, in particular, that expression and sharing often involves controversial views from voices that have no other outlet, and are often controversial themselves. It is a task that is not for everyone as it requires very high degrees of patience and understanding, advocating even for those who may be attacking you, and maintaining a constant allegiance to the principles of community access television.

Keali'i has a core strength of purpose that comes across to anyone who meets her. She has led in a very difficult environment and fought very hard to preserve 'Olelo as an important community resource. She also never pretends to be anyone but herself; what you see is what you get. There is a straightforwardness, a humility with strength that allows her to persevere.

The Director of DCCA is fortunate in that they have division chiefs who are appointed and bring individual skills to their specific positions. Jeff Ono in Division of Consumer Advocacy, Iris Catalani in Division of Financial Institutions, and Gordon Ito in Insurance Division are examples. It is the DCCA Director's job to be a chief of chiefs, to



It is my pleasure to submit testimony in support of the confirmation of Keali' S. Lopez as Director of the Department of Commerce and Consumer Affairs.

Besides being a great communicator with my sons, she always welcomes them with open arms, despite some of the poor choices they have made. Her unconditional love is appreciated by our entire family.

I was able to watch her develop two pillars – Wisdom and Compassion – that have guided her.

She has the wisdom that comes not from books but comes from experience in understanding what makes people tick and how to feed their inner need to grow and develop. TESIMONY ON GM 505 RELATING TO KEALIILALANIKULANI S. LOPEZ FOR THE POSITION OF DIRECTOR, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS

Chair Rosalyn H. Baker, Vice Chair Brian T. Taniguchi and members of the Senate Committee on Commerce and Consumer Protection, thank you for the opportunity to appear before you this morning.

I am very honored and humbled at being considered to serve the State of Hawai'i as the Director of the Department of Commerce and Consumer Affairs. I thank the Governor's transition team for its efforts and forwarding my name for consideration by the Governor. I appreciate Governor Abercrombie for his confidence in me and appointing me to the position. I am also appreciative of this Committee's time as you consider confirming my appointment.

I know I wouldn't be here today, if not for the strong support I have received from many people throughout my life. My husband David, our two sons Javier and La'akea, my parents

George and Lälani Segool, and my sisters Kapua, Amy and Annie who have never wavered in their support and commitment to me. I thank each of them for their continued encouragement.

I also appreciate many of the people whom I have worked alongside over the years. My work over the years has allowed me to partner with Federal, State, City and Local government entities; with public, private and charter schools; public and private colleges and universities; and

with a diverse range of individuals, non-profit and community organizations, and private businesses. Each encounter has been an opportunity to collaborate toward shared outcomes and a desire to make Hawai'i a better place for all. I thank them for their shared commitment and enthusiasm for our efforts.

I am a proud product of our island State, and have lived in Hawai'i for close to 50 years. My parents worked hard to provide for my three sisters and me. We came from a middle class family where we worked hard to provide for the needs and limited comforts for the family. This taught me early on that I had to work very hard and apply myself in order to achieve my goals. I also learned the importance of team work in helping my parents, along with my twin in raising our two younger sisters.

This experience and coming from a very large extended family where everyone pitched in to help each other, taught me a life of service and a desire to help others. Over the past twenty-five years I have had a special opportunity to serve the community, educational institutions and government agencies in several capacities and most recently as President and Chief Executive Officer of 'Ōlelo Community Media. My years at 'Ōlelo were very rewarding, demanding and life changing. My work required me to balance the needs of very diverse constituencies with an emphasis on equity to ensure that the organization was fair in its delivery of services to all. The unique focus of enabling others to exercise their right to free speech brings with it a formidable responsibility to both protect this right as well as hold members of the public to a standard of responsible speech that is constitutionally protected. Any decision that would impact this individual right was taken very seriously, and required prudent and judicious consideration when deciding to take action that would impact an organization or person's access to services or to the Public, Educational and Governmental (PEG) access channels.

In all my efforts whether it be work related or serving on Boards for non-profit organizations, my focus has been on building strategic alliances, developing shared long-term goals and objectives, and being thoughtful and purposeful in my efforts. Together with hard working and dedicated staff, and similarly committed and dedicated community partners, 'Ōlelo was able to increase its services and reach to all PEG access sectors. This included expanding two Community Media Centers in partnership with public schools to six centers on public school campuses; expanding 'Ōlelo's state-wide Youth Xchange Video Competition for students K-12 in public, private, charter and home schools to include partnerships with business and government agencies; providing video-on-demand via the internet for public and government access programming; partnership with the Senate to provide archived streaming of hearings that aired on 'Ōlelo; working in partnership with the State Administration, and the House and Senate to provide a studio in the capitol to enhance communication and information for the public.

My experience has enhanced my understanding of the importance of developing strong working relationships that are built on trust, mutual respect and shared objectives. My strength in these relationships is my ability to understand the needs and objectives of these business partners. Successful collaboration begins with transparency about objectives and expectations of all parties. It is important that any shared objectives benefit the needs and interests of the partners as well as the public and businesses we seek to serve. To achieve this greater good, it is easy to put aside any personal interests to achieve what is best for others and our overall shared outcome.

Additionally, my work at 'Ōlelo has provided me with a wide range of experiences, many of them complex and interconnected. These have included expanding services while reducing costs; negotiating long term ground lease agreements; effectively addressing delicate legal

personnel matters; navigating legislative efforts; facilitating emotionally charged situations; serving very diverse communities with significantly different needs and building a thriving community resource. All of this together with my life experience here in Hawai'i has helped prepare me for public service and has helped me be ready and capable of serving as the Director of the Department of Commerce and Consumer Affairs.

There are unique and critical skills I believe are necessary to be successful in serving the public, consumers and businesses. I have the ability to be open and listen, truly listen to what people have to say, to understand unique perspectives; remain open to all sides and not be predisposed one way or another; and demonstrate respect for each individual regardless of his or her background, position title or industry. I am also experienced at balancing multiple issues and expectations. This experience will lend itself to the regulatory necessities of the DCCA to protect consumers while facilitating the needs of the businesses and industries the department regulates and serves. Most importantly, integrity and transparency are necessary characteristics I will be able to share with the department and those we serve.

My goal is to increase the public's confidence in Government, approach the work we do in the department as a partnership with all those we serve and regulate, and increase the awareness of the department and its role in educating consumers and businesses alike with regard to the areas wherein the department has authority and responsibility. Many small businesses are busy trying to make ends meet, and I believe there is more we can to do help streamline their experience with department so they will see the department as an advocate for their success. Similarly, in regulating large industries such as utilities, finance, insurance and others, we have a shared interest in ensuring consumers rights are protected while also ensuring these businesses are able to thrive in Hawai'i. The public, our legislators and others want to know the department

will be held accountable and is achieving its regulatory mandates. This too is where transparency in the actions of the department will be critical.

I look forward to being able to accomplish this and more with the hard working and dedicated staff at the DCCA. My ability to motivate people around a common goal, to have staff feel good about the work they do and take pride in the fact that they have an opportunity to serve the public every day in an excellent manner are part of what I intend to bring to the department. I have had a chance to meet with many of the staff at the department and I can truly say so many of them are eager and awaiting the chance to improve and make a continued effort in serving our constituencies.

Finally, I would like to express my warm regard and appreciation to everyone who took the time to submit testimony or who came here to testify in person on my behalf today.
