# GM 549 - Charles A. Prentiss, Gubernatorial Nominee, Environmental Council

My name is Shannon Wood, a Kailua, O'ahu resident. Although I am submitting this testimony as an individual and not on behalf of any organization, I have a long professional as well as personal history working on a wide range of environmental, renewable energy & sustainable economic/agricultural development issues & projects.

I am writing to express my deep concerns about Charles Prentiss's nomination to the **Environmental Council** and urge that you consider more than his paper qualifications in your decision-making.

Although I had observed him as a member of the *Kailua Neighborhood Board* for quite some time, I first met Mr. Prentiss in 1997 during the first round of discussion about the **Ko'olaupoko Sustainable Communities Plan** and later during the initial phases of former **Mayor** Jeremy Harris's **Vision Plan Project** in 1998. Over time, I became increasingly uncomfortable being around him and then finally broke off attempts at trying to work with him on a vide variety of planning, zoning & environmental issues by the end of 1999 after a major confrontation over a special needs housing application.

Here are my concerns: The first is that Mr. Prentiss has failed to acknowledge and accept a major shift in planning theory from traditional growth patterns established in the 30 years following *World War Two* to what is now generally known as **Smart Growth**. Mr. Prentiss believes that living & working in close proximity - whether in defined business/commercial areas or in home-based businesses - are not appropriate except in dense urban centers. He is particularly adamant that communities such as Kailua must be kept residential - principally single-family detached housing with very limited multi-family, multi-generational & special needs housing and commercial activities - and that residents should commute to their jobs in urban areas.

My second concern is that in the nearly 14 years I've known Mr. Prentiss, I have never seen him take part in any *boots-on-the-ground* community service project. During that time, I have taken part in more than 125 such events in the greater Kailua area sponsored by more than a dozen organizations and have never once seen him at any of them. Granted, he has taken part in community discussions, workshops & information fairs on a wide range of planning & zoning issues, but that's very different from working on service projects.

I cannot speak for other organizations, but the environmental non-profit I work for always has opportunities for individuals with limited physical skills. For example, we're holding an **EARTH DAY Community Service Project** on April 23 and here's what was said in press

releases sent out earlier this week: ....and about ten individuals with limited physical abilities to register volunteers, set up & serve food, and coordinate other baseyard activities are particularly needed.

My third concern is Mr. Prentiss's style in interacting with others. He's not just unwilling to accept different views from his but also he is not open to allowing those views to be expressed.

My fourth concern is one that I think needs to be further investigated. Mr. Prentiss is a major officer in the *Democratic Party of Hawai'i*. Can he continue to serve in that capacity and be on the **Environmental Council** at the same time?

NOTE: I hold a much lesser office in the *Democratic Party of Hawai'i* so it's not a political thing as such. I remember when former *Governor* Linda Lingle nominated key *Republican Party* officials to several different boards & commissions that there were similar concerns expressed at the time. If it were an issue back then, then it should be an issue now as well. However, I do not have first-hand knowledge of what the rules are concerning the issue.

The final issue I wish to raise occurred in 2010 when Mr. Prentiss actually publicly (not legally) challenged my Kailua & Windward connections even thought my husband and I have been residing in Windward O'ahu since 1976. We first lived in Kahalu'u and then Waimanalo before moving to Kailua in 1978. We then moved to Kane'ohe Town in 1987before coming back to Kailua in 1994. I have no idea what his purpose was in challenging me..
