My name is John A. Ervin. Thank you for the opportunity to testify before this Committee. Governor Abercrombie's nomination, GM 592, to the Commission on Transportation is one of the greatest honors in my life. The possibility of serving my community, the Island of Hawai'i and the State of Hawai'i, being able to make a difference in the daily lives of our constituency is humbling.

Clearly transportation issues deeply affect everyone who is a resident of Hawai'i. On the neighbor islands our quality of life and the purchasing power of our income is directly related to transportation in all aspects of our lives. It is easy to point out deficiencies and difficult to have the vision to provide solutions. The advice from the members of the Commission on Transportation to the Commissioner of Transportation and International Affairs is crucial to the success of strategies for the flow of traffic, goods and services on which we all depend.

My work experience includes county, state, federal, elected official and entrepreneurial experience. From forest fire fighting, camping and recreation and timber stand improvement, I am a certified Forestry Technician and and certified Log Scaler, to owning and managing a restaurant and catering company. This gives me a unique perspective on government and private sector issues. Perhaps the most difficult experience I have had was being elected as a Member of the Lassen College Governing Board, eventually being elected it's president by my peers on the Board, and guiding the municipality through Chapter Nine Bankruptcy. According to our attorneys Lassen College was only the third municipality in the history of the United States to seek protection of Chapter Nine Bankruptcy. Almost all leadership positions require difficult decisions that take time to prove whether the decision was correct. I can proudly say that Lassen College is open and functioning 25 years after my tenure. I am currently the

President of the Maunaloa Shores Board of Directors. In that capacity I have hired competent personnel and completed deferred maintenance issues, without a special assessment, that have plagued the Association for up to a decade. As with most fiscal issues it is a question of vision and leadership.

Anyone with the powers of observation can see serious transportation issues in the Hawaiian Islands including gridlock on our highways to the costs associated with shipped consumer goods, to the cost of inter-island air fares. My father-in-law, Hiroshi Sasaki a Japanese citizen, was involved in a horrible accident on Highway 130 in Puna. His disabling injuries forced him to return to Japan. The yearly fatalities and virtually daily accidents on Highway 130 make it one of the, if not the, most dangerous Highways in Hawai'i. Hopefully my tenure, if confirmed, will see the settlement of the Hawaiian Ceded Lands issues involving sea ports and airports. However any settlement on the Ceded Lands issue must be decided the Kanaka Maoli and not a single Commissioner.

I am truly humbled by the testimony submitted on my behalf. I have read some of the testimony and wondered if they were testifying about the same John A. Ervin. We never see ourselves the way others perceive us. The testimony of community leaders on short notice, since Thursday March 24, at 3:30 PM, must give this committee an insight into my character, dedication, abilities and experience. The testimony submitted may not have included that I am not prone to long speeches. I believe in being brief and concise in my oral communication. I will endeavor to assist, not hinder, Director Glenn Okimoto in deciding the direction of the Commission on Transportation.

In regards to International Affairs, I have traveled all over the world including the United States, Canada, Europe, Africa, South America and Asia. I have family by marriage who live in three different Prefectures in Japan. They survived the recent catastrophe without major incident. I believe that the Aloha taught to me by my Hawaiian friends and hanai family as a youth has served me well in my travels. I have carried that Aloha with me my entire life. Aloha has not only allowed me to accept cultural, religious and ethnic differences, Aloha has taught me to celebrate those differences.

In conclusion, I extend my humblest appreciation and thank all who have submitted testimony on my behalf. I thank the Senate Transportation Committee for their time and consideration on my nomination in this busiest and crucial session of the Senate. 

Mr. Ervin may not know everything, but <u>he</u> knows that. He is not fearful of acquiring new information; knows when to ask a question, and can be counted upon to point out the elephant in the room and bring it to the table. If there is anything that "goes without saying" it is likely he will say it.

If it is required to present someone to make a positive impression upon intelligent, informed people, send Mr. Ervin. If he needs further information on a subject, he will seek it. If he needs help, he will ask for it.

I have been associated with John Ervin for over 20 years and have no regrets from it. He is a staunch ally and close friend. I fully endorse his appointment.
