Senator Baker, Senator Taniguchi, and members of the Committee:

Thank you for the opportunity to present myself as an applicant for reappointment to a position on the State Board of Nursing. As requested, my resume and references are attached and my responses to your questions follow below:

Why do you wish to continue being a member of the State Board of Nursing?

I wish to continue as a member of the Board of Nursing because, as Co-Chair of the Practice Committee, I find myself with a plan of work begun in 2008 that has not yet been completed. The amendments to HAR 89-c, signed by the Governor last December, took a year to draft and included input from all segments of the nursing community. During the time the amended Rules were proceeding through the 26 step approval process, HRS 457, relating to nursing, underwent two major amendments. Bringing the Rules into alignment with the latest version of the statute will be the first task of the practice committee in the coming year. Once aligning amendments have been submitted, and if there is not a more emergent issue, the committee will look at pain management, palliative/end of life care, telehealth, and e-prescribing for possible future amendments. I would appreciate the opportunity to continue the work I have started.

What is your perception of the role/responsibilities of a member of the Board?

The Board of Nursing serves as the guardian for public safety as it relates to the education and practice of nurses. Board members put aside their employment and professional allegiances in favor of the greater pubic good. They contribute knowledge and perspective from their roles as educators, clinicians, administrators and representatives of the pubic. Board members are responsible for attending Board and committee meetings, for coming to meetings prepared to conduct the business of the Board, for fulfilling commitments made to the Board for internal or external activities, for educating themselves on nursing issues beyond the immediate scope of their professional involvement, for maintaining the confidentiality of executive sessions, and for recognizing a conflict of interest and responding appropriately. Recognizing that nursing is a constantly evolving profession. Board members must be future oriented, willing to explore relevant learnings from our own and other professions, analyze issues, and formulate appropriate regulation to guide employers, nurses, and the communities they serve.

Based on your understanding of the board's role, why do you believe that you are

qualified to continue serving on the board? Please include a brief statement of your skills, expertise and/or knowledge that would assist/strengthen your decision-making ability as a continuing member of the Board.

I believe I have a good understanding of the responsibilities of the Board of Nursing, the statutory and Rule making processes, and disciplinary procedures. I have been a registered nurse for 36 years and a nurse practitioner for 33 years. 21 of which have been in Hawaii. I have a master's degree in nursing from the University of Hawaii and am nationally certified as a women's health nurse practitioner. I have practiced in hospitals, clinics and private medical offices, and have taught at the UH School of Nursing. I keep up to date on nursing issues and trends through conferences and extensive reading. I write well and am highly skilled at researching issues from multiple sources and a variety of perspectives. In addition to my contributions to the newly adopted Rules, I also wrote a newsletter article and gave multiple presentations to nursing groups to ensure broad understanding of the many changes to nursing regulation that took place during the last three years. I hope to continue to identify and work toward removal of barriers that impede nurses from practicing to their full capabilities in order to expand access to high quality care to all the citizens of Hawaii.
