 - I perceive the role and responsibilities of a member of the Hawai'i Historic Places Review Board are to protect the public's interest in regard to the preservation of the historic and cultural places and environments that make Hawai'i special.

Secondly, my professional expertise in the field of architecture provides me a unique and appropriate perspective in understanding historic places and a working knowledge of the necessary requirements toward eligibility for the State Historic Register.

Lastly, having served for the past 5 years on the board of the Historic Hawai'i Foundation, and as the President-elect, I have been exposed to and participated in many of the most important discussions regarding historic preservation of our historic places and cultural resources.

(d) What do you hope to accomplish during your term of service?

I hope to list increased awareness and preservation of many more Hawaiian cultural places and sites as an accomplishment of my term of service.

In consideration of **GOVERNOR'S MESSAGE 690 -**SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE HAWAII HISTORIC PLACES REVIEW BOARD, GUBERNATORIAL NOMINEE ROBERT K. IOPA, FOR A TERM TO EXPIRE 6-30-2014

The Department of Land and Natural Resources (Department) supports the gubernatorial appointment of Robert K. Iopa to the Hawaii Historic Places Review Board for a term to expire 6-30-2015.

The Hawaii Historic Places Review Board was established under Section 6E-5.5, Hawaii Revised Statutes (HRS), to: (1) Order and enter historic properties into the Hawaii Register of Historic Places on the basis of their value to Hawaii's heritage; (2) Evaluate and, when appropriate, recommend the nomination of historic properties to the National Register of Historic Places; (3) Review the state survey of historic properties; (4) Review the content of the State Historic Preservation Plan; and (5) Maintain the Hawaii Register of Historic Places (including all those listed on the National Register of Historic Places).

Section 6E-5.5, HRS, also requires that the Hawaii Historic Places Review Board include at least one professionally qualified member of each of the following disciplines: Archaeology, Architecture, History, and Sociology. In addition, there shall be on person knowledgeable in traditional Hawaiian society and culture.

Mr. Iopa graduated from California Polytechnic State University in San Luis Obispo, California, with a Bachelor of Architecture degree in 1994. He has since worked at three architectural firms: Wimberly Allison Tong & Goo (1994-1999), Architects Hawaii (1999-2000), and WCIT Architecture (2000-present). He has served as an Adjunct Professor at the University of Hawaii

On behalf of Historic Hawai'i Foundation (HHF), I am writing in <u>support of confirmation of</u> <u>Robert K. Iopa</u> as a member of the Hawai'i Historic Places Review Board.

Since 1974, Historic Hawai'i Foundation has been a statewide leader for historic preservation. HHF's 850 members and numerous additional supporters work to preserve Hawaii's unique architectural and cultural heritage and believe that historic preservation is an important element in the present and future quality of life, economic viability and environmental sustainability of the state.

Robert K. Iopa is Architect and Principal with his own firm of WCIT Architecture. He has served on HHF's board of trustees since 2006 as both a director and officer. In his work with Historic Hawai'i Foundation, Mr. Iopa has helped develop training materials and professional development seminars related to historic preservation and design. He has also chaired the annual Preservation Honor Awards committee, which reviews and recognizes exemplary projects for consistency with standards, guidelines and best practices for preservation. His own design work on the Royal Hawaiian Hotel's recent rehabilitation was found to comply with best preservation practices and has been award winning.

Mr. Iopa's design practice is focused on providing culturally appropriate and socially responsible design solutions for the Islands. His research and design work is rooted in Hawaiian culture and history, with knowledge of and sensitivity to the history, culture, traditions and practices unique to the people and places in which he works, especially from a native Hawaiian perspective and tradition, but with respect for the uniqueness and value of all people of Hawaii.

Mr. Iopa will also bring a thoughtful and collaborative demeanor to the Review Board. His conduct is respectful of the input and opinions of others, and he works diligently to understand and follow the standards that are to guide decisions, offering fairness to all participants in a process.

These professional qualifications, experiences and personal characteristics will enhance and support the Review Board and the State Historic Preservation Division.

The Historic Places Review Board is responsible for maintaining and adding historic properties to the Hawai'i State Register of Historic Places, nominating historic properties to the National Register of Historic Places, and also reviewing the state's inventory of historic properties and the content of the statewide preservation plan.

The composition of the Review Board is required to include professionally qualified members in the fields of archaeology, architecture, history and sociology, as well as knowledge of traditional Hawaiian society and culture. The state board is also required to meet the qualifications in federal law (see HRS §6E-5.5) and to conduct its meetings and hearings in compliance with open government and fundamental fairness procedures.

These responsibilities are vital to the protection and perpetuation of historic and cultural properties across the state. These functions are also necessary for the State's historic preservation division to remain a federally-recognized program. Last year, the federal agency responsible for certifying state programs for compliance with federal law directed the historic preservation to complete corrective actions in five areas, including the National Register program, the statewide preservation plan, and the statewide inventory and survey (see National Park Service. Report on Hawai'i State Historic Preservation Division Operations. March 19, 2010).

We look forward to seeing the successful turnaround of the Division and completion of the corrective action plan. We believe that Mr. Iopa's appointment to the Hawai'i Historic Places Review Board will help move the State forward in a positive and beneficial way.

Therefore, Historic Hawai'i Foundation recommends approval of the appointment of Robert K. Iopa as a member of the Hawai'i Historic Places Review Board.
