Good morning. My name is Dante Carpenter, a concerned citizen of Hawaii whose residence is in the Salt Lake area of Honolulu, Hawaii. I have occupied positions as former state senator and OHA Administrator. I am in strong support of the nomination forwarded to you by Governor Neil Abercrombie of Sesnita A. D. 
