TESTIMONY TO  
THE SENATE COMMITTEE ON EDUCATION

RE: HB 1313, HD 2 – Relating to the Issuance of Special Purpose Revenue Bonds to Assist Windward Nazarene Academy

Chair Tokuda, Vice Chair Kidani, and Members of the Committee,

My name is Robert Witt, executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide. We would like to testify in support of a measure introduced by one of our member schools, Windward Nazarene Academy, which is seeking approval for a Special Purpose Revenue Bond.

The Senate Committee on Education has supported similar measures in years past and we are here to acknowledge and recognize your advocacy and support of the ongoing effort by HAIS to encourage its member schools to use Special Purpose Revenue Bonds as an essential strategy for leveraging capital funds urgently needed for campus development and improvement projects.

Private schools in Hawaii serve everyday families from all walks of life. Many students attending private schools receive financial aid to defray the cost of tuition. It is our steadfast belief that private schools serve an important public purpose here in Hawaii by helping to prepare the next generation of young people for college, careers, and citizenship.

In addition, Special Purpose Revenue Bonds do not in any way divert funds away from public schools, while stimulating Hawaii's economy via construction job creation.

For these reasons and others that may be addressed during discussion of this measure today, HAIS **strongly supports HB 1313 HD 2** and the approval of issuance of a Special Purpose Revenue Bond for Windward Nazarene Academy.

Dear Chair Tokuda, Vice Chair Kidani, and members of the committee,

My name is Kay Hishinuma, and I am the school administrator of Windward Nazarene Academy, a private school that serves the children of the Windward side of Oahu. Our school provides educational services for 243 children from preschool three year olds through eighth grade. Ours is a diverse population, reflective of the community we serve. Because WNA works to keep tuition affordable for as many families as possible, our students come from all socioeconomic levels. We believe strongly in the importance of a partnership with our families in the education of their children, knowing that the best chance of success in our mission to educate is to be found in consistency between school and home environments. Embracing families and building relationship is the bedrock upon which we stand.

Windward Nazarene works to give our children the best of what private education has to offer. Our curriculum is academically challenging, and we seek to expand and improve upon it continually. In light of this, WNA has embarked upon several initiatives to enhance the educational experience of our students. We are in the process of accreditation, a process that has yielded rich results in self awareness and focus. We have embarked upon a sustainability program, serving as a pilot school in HAIS and Ulupono's Grow Hawaii Project. Our school garden includes a vermicasting program, and hydroponic garden with plans to expand to aquaponics in the near future. Our sustainability initiative also includes the installation of photovoltaic panels to generate environmentally clean power and as an example to our students in environmental stewardship. Plans for a truck garden (a garden that is planted in an actual truck bed and driven out into the community to teach gardening) are under way.

More than programs, Windward Nazarene Academy is a school built upon relationship, recognizing that it is in relationship that we learn and grow together. WNA seeks to build close partnerships with parents in the nurturing of our children. In that partnership, we work to build consistency between the school and home environment. It is in that consistency that children find the best support to learn and grow. In relationships, children not only acquire knowledge, but learn the art of kindness, compassion, patience, tolerance, and servanthood.

For many years, parents have asked us when we would pursue a high school program, loathe to leave the school and move on to another. My own children have walked this campus and grown within its walls. My last child is in the seventh grade, and I can identify even more with those parents who have waited and hoped for all these years. We believe that the time has come to make concrete steps in that direction. In order to pursue this goal, we hope to secure adequate funding.

We believe that an affordable high school program is a need here on the Windward side, and hope to be a part of providing that option to this generation and generations to come. Thank you for your consideration of HB 1313, a Special Purpose Revenue Bond to assist Windward Nazarene Academy.
