I am writing in support of an amendment to the law which would allow the sale of a traditional staple prepared using traditional implements. Pa'i 'Ai is a nutritious food which formed the basis of the indigenous diet. At the time of contact, observers aboard Captain James Cook's Discovery were impressed with the robust good health, the industry and ingenuity of the Native Hawaiian people. In the ensuing two hundred years, the western diet has wrecked havok among our indigenous population, which now suffers staggering rates of obesity, diabetes, cardiovascular disease. I am a Pediatrician and the overwhelming majority of children who suffer from being overweight are of Native Hawaiian ethnicity. Although there are concerns that the traditional implements cannot be sterilized, there is no research that has documented an increased bacterial load of Pa'i 'Ai when compared to milled poi. In fact, it is possible that chemical characteristics of the porous stone, wooden board and ti leaf may retard the growth of pathogenic micro-organisms. More research is needed. Meanwhile, consumers should have the choice to purchase this wholesome alternative.
