#### Chair McKelvey & Members of the Committee:

My name is Maurice Morita, Assistant Director of the Hawaii Laborers-Employers Cooperation & Education Trust (Hawaii LECET), a partnership between the Laborers Union, Local 368, and our Unionize Employers, and we STRONGLY SUPPORT HB 1509 which provides government purchasing information required to be disclosed under the freedom of information law includes bid schedules, contract awards, and any addendums and amendments. It requires the information to be posted on the contracting agency's website within one business day of availability.

By passing HB 1509, this will require all contracting agencies to be more transparent in their bid schedules, contract awards, addendums, and amendments.

We would like this bill to be applicable to all state and county agencies including autonomous and semi-autonomous agencies, such as, University of Hawaii system, Board of Water Supply, etc.

This bill will amend HRS 92-F, Uniform Information Practices Act (Modified).

The current law only requires bid results to be posted, such as, on a bulletin board at the agency's office, though there are some that do post bid results on their website. Most agencies do not post bid schedules, contract awards, and any addendums and amendments on their website.
