**HB285 RELATING TO MEASUREMENT STANDARDS**

Chair Tsuji and Members of the Committee:

HFBF on behalf of our commercial farm and ranch families and organizations is in strong support of HB285, establishing a fee for services process in the Commodities Branch of the Hawaii Department of Agriculture.

In 2005, the House of Delegates governing the policies of the Hawaii Farm Bureau Federation provided direction to the organization that a fee for service program could be used to ensure timely delivery of services to our farmers and ranchers. As State budgets tightened, the choice to go without services was not an option to the industry. Without timely inspections and or certifications, movement of agricultural products would be impacted, possibly losing markets due to shipping delays or loss of product integrity.

This measure parallels the invasive species fees and other measures we have supported to ensure that our industry can continue to function. As we support these measures it is critical that the Department identify ways to maximize productivity to minimize costs.

Chairperson Tsuji and Members of the Committee:

Thank you for this opportunity to provide testimony on House Bill 285. The bill seeks to establish a weights and measurements special fund, with the intent of requiring the department of agriculture's measurement standards program to be financially self-supporting. The Department supports the intent of the proposed bill.

The branch forecasts the annual income from the collection of licensing fees to exceed \$485,000 during the coming fiscal year and to be further increased in 2013 as a result of newly implemented rules. Presently, annual expenditures for the weights and measurement program is \$480,000.

As a result of reductions in force, eight positions were eliminated; one on Maui, one on Hawaii County, and six on Oahu. The branch staff currently includes three device inspectors, two clerical staff responsible for licensing and fee collection and one state metrologist running the National Institute of Standards and Technology certified calibration laboratory.



An analysis of salaries, benefits, other current expenses, administrative expenses and central service assessment fees show that the program will still need general fund support.

## RELATING TO MEASUREMENT STANDARDS

House Bill No. 285 establishes the Weights and Measurements Special Fund into which all application fees and licensing fees are deposited and used for covering the costs of administering the measurement standards program in the Department of Agriculture.

As a matter of general policy, the Department of Budget and Finance does not support the creation of any special fund which does not meet the requirements of Section 37-52.3 of the Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 285, it is difficult to determine whether the fund will be self-sustaining.
