**Subject: House Bill No. 372  
Related to Economic Recovery**

The Department of Planning and Permitting **opposes** House Bill No. 372, which would reduce county requirements for affordable and workforce housing by 40% percent.

We recognize the need for affordable housing, and have built our own programs to respond to this need, as did the Neighbor Island counties. Presently, the City & County of Honolulu require projects requesting a rezoning, to provide 30% of proposed residential units to be available for families who earn one hundred 140% of Oahu's area median income (AMI). A reduction of 40% of the existing 30% requirement would result in an allocation of 18% of new units being designated as affordable.

We understand the need to establish a reasonable threshold for the provision of affordable units which does not overly burden a development so as to make it financially infeasible. The ability of any particular development being able to finance the subsidies necessary to construct affordable housing must be continually evaluated and, if necessary, adjusted, so the costs of affordable and

market-rate housing are in sync with the demand and financial capability of the marketplace, so as to produce a greater quantity of affordable units.

We are proud of our county's affordable housing programs. As has been done in the past, if we feel a temporary hiatus or relief is needed, we can adjust our programs. An across-the-board mandate by the state is not warranted and is an intrusion of home rule.

While we recognize the desire to create new jobs in the construction industry, it seems short-sighted to reduce affordable and workforce housing production and increase market housing, which most construction workers will be unable to afford. We are also optimistic that construction of the rail transit system will shortly be underway, addressing the employment concern.

Please hold House Bill No. 372. Thank you for the opportunity to comment.

RELATING TO ECONOMIC RECOVERY**

Thank you for the opportunity to testify in opposition to this important measure. The purpose of this measure is to grant temporary relief from county housing requirements as recommended by the construction industry task force to stimulate housing construction statewide.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I oppose this measure for the following reasons:

1. A seemingly arbitrary reduction in affordable and workforce housing required of a developer lacks guidance. In the crafting of Maui County's Residential Workforce Housing Policy, I have seen firsthand how affordable and workforce housing policies can vary considerably from county to county; one size does not fit all.
2. Counties are in the best position to measure and address the housing needs of its citizens. State intervention on this county issue usurps authority and repudiates from home rule principles, without justification.
3. Maui County has already taken steps to address both the lack of workforce housing being built as well as the stall in the construction industry. By ordinance, Maui County is required to review its residential workforce housing policy every two years. Changes were made to this policy last year to reduce the amount of workforce housing required in certain types of developments from 40 to 25 percent in response to economic conditions. Further review is anticipated this year.
4. If the intent of this legislation is to assist economic development by stimulating the construction industry, then the State should encourage more affordable housing production, not less. Such a strategy of providing incentives for affordable housing not only avoids State intrusion in county programs but directly addresses the needs of workforce housing for construction workers and other residents.

For the foregoing reasons, I oppose this measure.
