Aloha, I'm a Sergeant/Deputy Sheriff III, for 30 yrs, currently at the HIA since 1999, a widower, a father of (3), grandfather of (3), I testified in 1987 before Sen. Mike CROZIER's Act 211 Hearing, then a housekeeping measure, we then were w/the Judiciary (HGEA), to be absorbed in the new Dept. of Public Safety in July 1990. The Corrections half from DSSH (UPW) had already formulated the PSD infrastructure in 1989 to control our hiring, training, budget, asset, forfeiture funds, in attempts to attain our Police Powers & relinquish our name, integrity, commission, title - Sheriff, Deputy Sheriff, Sheriff Dept. to "Special Services Deputy's." Were in jeopardy of being lost forever. I testified again on the Historical aspects, merits and retention of our identity, recognized as other LE positions nationwide, Marshals, Police, Sheriff have clear and distinct duties that require proper collective bargaining representation. To eventually include all state LE units ie; AG's, DLNR, Harbors, NED, Sheriff's, etc. is essential for consolidation of jurisdictional powers, defined authority, budget, and proper training w/accreditation, a sustained mission w/support, defined authority, short/long term Goals & Objectives in concert with the 2010 PSD audit. We are again at critical juncture in our quest for political survival & recognition. Our current need for redress & grievances, begs your support of HB491, Thank you & Mahalo
