Aloha, on behalf of my ohana and myself, I would like to thank House of Representative's Chairman Marcus OSHIRO, Vice Chairwomen Marilyn LEE for giving me the opportunity to provide testimony in support of HB492. I've been a deputy Sheriff since 1981, this comming April 16th will mark 30 yrs. Initially with the Judiciary now with Dept. of Public Safety, Executive Branch and I've witnessed neglect by department managers who made decisions and operational changes where the decision maker lacked the basic pre-requisites in Law Enforcement / Deputy Sheriff recruitment which was compounded with managerial deficiencies. I'm a Sergeant/Deputy Sheriff III now with the H.I.A., 3rd Watch Patrol Section, currently working a Special (Off Duty) post to supplement my lost furlough days off to support my family. I've been widowed since 2003, a single father of (3) and a grandfather of (3). I testified before Sen. Mike CROZIER in 1986 when the Dept. of Public Safety was being created. To consolidate all State LE functions in a Housekeeping Measure, we were all lumped together in Act 211, fragmented, lacking a joint mission, future projections, and long term goals. Simply thrown together with the larger Dept. of Corrections (DSSH/UPW) has not resolved the dilemma. Our current State LE (TSD) Training Academy operates without minnimal P.O.S.T. (Police Officer Accreditation Standards) and lacks the respect and integrity afforded a true Sheriff's Agency and Academy. This comming 04-16 marks my 30 yrs as a Deputy Sheriff, w/two prior years w/FBI. The current Bills you now chair following the Recent 2010 PSD Audit are the first measures to correct this gross flaw and provide the necessary infrastructure for a State Law Enforcement (Sheriff's) Recruit and Training Academy. Recruit, In-Service and Re-Call Training will be greatly enhanced and supported by deputies, officers and the public we serve. It's true that the State LE has expanded it's mission with less resources, however, with the proper management under a defined separate LE manadte and a distinct Pro Law Enforcement Administration for support & accreditation standards, is vital if the Agency (Department of the Sheriff) is expected to survive. I'm grateful for this opportunity to testify and humbly ask for your support and passage of HB492, mahalo
