I thank the legislature for the many efforts in support of this resolution. I also thank the Department of Health officials and technical staff for their past and ongoing support of this activity that will contribute to restoration of a shellfish industry in Hawaii.

We have had several very positive meetings on issues required to gain the needed lab certification, and to subsequently establish a laboratory evaluation officer.

At present the DOH has a certification program for imported shellfish but not for locally grown shellfish. Locally grown shellfish are presently exported as juveniles to West Coast sites for growout and then shipped back to Hawaii for local sale.

The lack of a Statewide Classification Program for shellfish growing areas has been a roadblock to establishing a shellfish aquaculture industry in Hawaii for decades.

Work to date has recognized the most significant issues toward the end of securing this most promising segment of local food production for local consumption. All evidence to date indicates the absence of growth, taste, economic, or production hurdles to the revitalization of this local aquaculture.

We at Analytical Services Inc. are committed to assisting this new industry segment. Establishing the laboratory certification process is critical to marketing edible bivalves that are grown in Hawaii.
