Re: H.C.R. No. 309 / H.R. No. 274

The Hawai‘i Civil Rights Commission (HCRC) staff submits this memorandum to inform the Committee that the HCRC has not taken a position on H.C.R. No. 309 and H.R. No. 274, because the HCRC Commissioners have not had the opportunity to review and take a position on these resolutions. The first meeting of the Commission since the introduction of the resolutions is scheduled for April 6, 2011.

H.C.R. No. 309 and H.R. No. 274 urge the proclamation of the second week of August 2011 as “Hawaii State Assistance Animal Week.” While the HCRC does not have a position on H.C.R. No. 309 and H.R. No. 274, we can offer background information on the use of assistance animals by persons with disabilities under our state civil rights anti-discrimination laws, as context for discussion and consideration of the resolutions.

As used in the resolutions, “assistance animal” means an animal that assists, supports, or provides a service to a person with a disability, including service animals and comfort animals. Persons with disabilities may request the use of an assistance animal as a reasonable accommodation needed to perform their jobs, have equal enjoyment of their housing accommodations, and access public accommodations and government services, although there are different applicable legal standards under the various federal and state laws that protect against disability discrimination in these areas. Assistance animals should not be considered or treated as “pets.” The use of assistance animals makes it possible for persons with physical or mental impairments to have equal opportunity and full participation in society and community.

The HCRC takes its role and authority to testify and make recommendations to the legislature very seriously, and will do everything possible to assist you in your consideration of bills and resolutions that affect HCRC jurisdiction and civil rights. Please let us know if we can provide you any additional information. Thank you for your understanding and patience.
