This is to request that you consider making the following changing to HCR 318/ HR 283:

On Page 2, line 35; which currently reads:

(1) The Chairperson of the Hawaiian Homes Commission, who shall serve as chairperson of the task force;

To:

(1) The chairperson of the task force shall be voted upon by the members of the organizations involved and shall report back to the Chairperson on the Hawaiian Homes Commission;

Furthermore, if we could amend Page 2, line 40; which currently reads:

(3) One member of the Molokai Farmers Alliance

To:

(3) One member of the Molokai Homestead Farmers Alliance

Also, if we could amend Page 3, line 2; which currently reads:

(6) One member of Kaa'akea Homestead Association;

To:

(6) One member of Kapa'akea Homestead Association;

In addition, if we could add two more members to the taskforce:

1. One member from Ho'olehua Livestock Association
2. One member from Ho'olehua Homestead Association
