Dear Ms. Mau-Shimizu:

Thank you for your letter of May 12, 2008 forwarding a copy of House Concurrent Resolution No. 194, S.D. I, passed by both chambers of the Hawaii Legislature. This resolution requests the Navy clear the coastline of lower Waipahu from invasive plant-life and excessive foliage for safety and aesthetic purposes.

The Navy owns the lands up to the extreme high water mark, which includes the mangrove patches that have formed along the shoreline in question. The lands directly adjacent to the mangrove patches are publicly and privately owned and are outside Navy control. The shoreline in this area is not fenced, making it extremely difficult to restrict or control access to the harbor and the mangrove patches.

The Navy shares the State's concern for reducing safety and aesthetic problems along the shoreline. The Navy has removed mangroves at other similar areas around the harbor and will request funding through its budget process to continue this effort. The Navy is currently planning a survey of the area to determine the extent of the problem and the clean up that will be needed.

The condition of the lower Waipahu coastline is a matter of concern to the Navy. Please be assured that the situation will receive serious attention as the Navy concentrates on and prioritizes its many property management needs in Pearl Harbor.

The Department of the Navy deeply appreciates the State of Hawaii's support of the Sailors and Marines assigned to Pearl Harbor. As always, if I can be of further assistance, please let me know.
