

### SB101 SD1 HD1 RELATING TO HEALTH

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> SB101 SD1 HD1, which would exempt the preparation of hand-pounded poi from certain Department of Health (DOH) requirements regarding food safety. The bill would also impose labeling requirements on hand-pounded poi not made in approved food-processing facilities and authorizes DOH to issue cease-and-desist notices for problematic hand-pounded poi producers.

Our traditions hold that kalo is the elder sibling of the Native Hawaiian people. Poi, which is made from kalo, is the staple of our traditional diet. While poi mills have provided our communities with poi for many years, the traditional practice of hand-pounding poi is enjoying a powerful resurgence today. We must nurture this movement, as it supports our local agricultural industry, ensures food security and promotes a healthier diet, all while encouraging one of our most important Native Hawaiian cultural practices.

OHA understands and appreciates DOH's sanitation concerns relating to the preparation of pa'i 'ai that will be sold, and we commend DOH for working with the community to find a solution to this important issue. We believe that SB101 SD1 HD1 represents a reasonable compromise that allows for hand-pounded pa'i 'ai to be sold; preserves DOH's ability to protect public health; and informs consumers about the product.

Therefore, OHA urges the committee to PASS SB101 SD1 HD1. Mahalo for the opportunity to testify.

Aloha mai kakou,

My Name is Robert G. Kealohapumehana Domingo and I am writing today on behalf of myself, my wife and my four sons named above. I also speak with full support on behalf of my parents Robert P and Jody Domingo of the same address, and in addition my siblings and their children totaling 6 adults and 6 children.

Our ohana fully supports SB101 SD1 HD1 in it's current form and do not recommend further amendment. As a Hawaiian family and firm believers in the revitalized Hawaiian culture, we have all been raised eating poi. In recent years, thanks to opportunities I have been fortunate enough to have been given, our entire family has been reintroduced to a time honored tradition practiced by our ancestors called kui ai, the art of hand pounding poi.

As a current "practitioner" of kui ai, I have had the opportunity and responsibility to actively hand pound poi for the past several years. I have learned much about taro, and about my innate family relationship to Haloa. I have also been able to witness first hand the many benefits of eating and producing hand pounded poi or pai ai and have been able to share and pass on the things I have learned not only to my own family, but to many others. As the husband of a kumu or teacher and as a member of the Board of Directors at Ke Kula O Samuel Kamakau LPCS, I have had the opportunity to share and teach kui ai to several hundred children. As a member of the community, I have also been able to share and teach kui ai at many events and venues ranging from the Aha Kane, Hawaiian mens conference, Hawaiian cultural workshops at Papahana Kuaola, community Hawaiian cultural based education program in Waipao, and many others.

My family and I support SB101 SD1 HD1 for several reasons:

- It will allow current and future practitioners of kui ai to not only have the ability
  to make a subsistent earning, but to be able to share their hand pounded product
  with the general public. Current Department of Health regulations control the
  distribution of poi or pai ai to the general public whether the product is sold or
  not.
- 2. It will promote the art of hand pounding poi by allowing small and upcoming practitioner to produce an equitable product by waiving the need for a certified kitchen which in turn will reduce cost burden.

- 3. It will allow the traditional art of kui ai to remain pure to its original form and element as well as it traditional implements including the pohaku kui ai or poi pounder and papa kui ai or poi board. These implements are recognized culturally and scientifically to be necessary to produce tradional poi or pai ai.
- 4. It will help to easier provide and make more readily available a product known for excellent health benefit.
- 5. It will also help to promote the farming of good quality "starchy" taro which is needed when hand pounding, thus adding value to a locally produced agricultural crop.
- 6. SB101 SD1 HD1 has been a coordinated effort with the current Dept. of Health administration to assure it is feasible, responsible for public safety and also enforceable for the department. It will actually hold the kui ai practitioner to a higher standard of safety training than other food related industry by REQUIRING a food safety course be taken, by requiring a posted label and description of product including the producers name and a notification that the product was not produced in a certified kitchen, thus allowing the consumer to make a conscious decision when purchasing the product.
- 7. It will have positive impact on the current economy by making a new job market available, increasing demand for farmers as well as possible other subsequent industry including production and sale of implements and the need for training of producers.

As you can see, SB101 SD1 HD1 offers many benefit to producers, consumers and more. It is widely supported by practitioners, poi millers, taro farmers and poi and taro lovers across Hawaii. I again ask you as elected officials to do everything within your power to pass this bill, without further amendments. Again on behalf of myself, my wife and our ohana, we thank you for concidering our concerns and desires as members of this community.

#### Aloha Honorable Committee Members:

I live in Wailuku. I am a member of the Taro Security and Purity Task Force, created by the Legislature in 2008 (Act 211), but I write to you as an individual and a taro farmer who has been hand-pounding pa'i'ai and poi for more than 20 years and I strongly support SB101 SD1 HD1.

The "Legalize Pa'i'ai 'Ohana", a group of taro growers, hand pounders of pa'i'ai, and poi eaters, has worked proactively for several months with the Department of Health to craft language and standards appropriate to this traditional food into a bill, SB101, that would allow the revival of the practice of ku'i 'ai (hand pounding of taro with stone and board) and the sale of their product using a similar framework as Hawaii's cottage industry honey production law. The current version of the bill, SB101 SD1 HD1 has the support of DOH and a broad group of hand pounders, millers, consumers, cultural practitioners, educators, youth, and taro growers throughout the state, including many in Maui County.

There are a number of enlightening and enriching dialogues that occurred to reach this consensus of support that may help lawmakers in their decision today. The topics ranged from what were the historic and existing poi making practices and laws; how poi became a food "hazardous" for consumers; the difference between ku'i (hand pounding) and milled poi; the economic impacts and potentials to growers, millers, our youth, and consumers; impacts on Hawaiian health and culture; and, food and family self-sufficiency under the constraints of an ongoing recession. We have all learned much in the process – and found so much along the way.

The context of why this bill is before you may be best understood by the following:

Laws Governing Poi Quality and the Difference Between Milled and Hand Pounded Poi/Pa'i'ai

The late 1800s through the 1930s was a time of changing conditions in society and in poi making. This period was the transition from individuals to groups of poi makers gathered at "poi shops," from hand pounding with board and stone to machine milling, from supplying the family (a few hundred pounds per week) to commercial production (thousands of pounds per week), from Hawaiian to non-Hawaiian producers (Japanese and Chinese taro growers and millers), and from pounding at home to shops located near other businesses such as stables and laundries which attracted flies, with poor drainage and plumbing, and often lacking in a potable water source. The integrity of stream water used by early poi shops as the source of "potable water" (Olszewski, Bishop Museum 2000) was severely compromised in many districts (reduced, warmer, turbid flows due to diversions and erosion from deforestation by cattle and sugar).

The first DOH ruling regarding sanitation for poi and pa'i'ai production in 1911 referred *only* to shops and mills and it is clear from the language of the law that this was due to the conditions at the turn of the century described above (Lebo et al. 1999; Olszewski 2000). Writing in 1914 and 1917, McCaughey suggested that malahini (newcomers) considered the hand pounding they observed to be unsanitary and preferred the mills (Hawaiian Forester and Agriculturist); however his comments are also focused on poi shops and not the traditional sites or manner of preparation known to Hawaiians. For those unused to the type of food consumed in Hawai'i or who believed that dazzle of modern machinery was our best future, hand pounding was a thing to be relegated to the past. Yet, we know from earliest written records that when it came to interpretation of

traditional Hawaiian practice that misunderstanding was common. Poi making's earliest history and hand pounding by Hawaiians through the 1930's is described as an activity full of attention to cleanliness and care in handling (Handy and Pukui 1958; HEN v1 pg976-984; Pukui 1967, pg428). Olszewski writes "These traditions were not observed in many commercial factories operated by non-Hawaiians (Ibid 2000, 55-72)." Inspections of mills and poi products conducted from 1911 through WWII included sampling of poi for residue (ie. taro skins, dirt, bugs, etc) and "solidity" (percent taro solids to water).

From the 1880's through the 1930's, dozens of photographs capture images of "poi" which stood up off the board or hung from "one finger" because of its density (Bishop Museum and State archives). If the poi found on store shelves today were judged by the earlier standards set by kupuna, it would have received the protests of many of Hawaii's residents who preferred pa'i'ai and a much thicker poi. A Honolulu Advertiser article on July 7, 1944 described how opponents to watering down commercial poi below 30% solids considered such poi "pig food" that was unfit for human consumption. Objectors from numerous Hawaiian organizations of the time called it "an insult to the Hawaiian people." This is by no means a slight to today's poi millers. Rather, it illustrates the clear difference in product as seen through the eyes of Hawaiians — and how few producers and consumers, Hawaiian or otherwise, are familiar with this prized quality being revived on the boards of a new generation of hand pounders.

After WWII, hand pounded poi disappeared from the market along with its practitioners. So few hand pounders continued to ku'i kalo, or pass on those skills, that the majority of today's Hawaii residents, even those who grow taro, have never eaten pa'i'ai as it was made in past centuries. This new generation of practitioners

Forward to the present and we found that current Department of Health laws were written for poi mills and poi at a time when there were no longer hand pounders selling their product. It is no wonder then that DOH staff and millers were unfamiliar with the character of traditional pa'i'ai and differences in conditions that might support hand pounding. Inadvertently, these rules make the distribution and sale of traditionally prepared pa'i'ai and poi illegal in the place of its birth.

The current law is economically and physically burdensome, if not impossible, to comply with for small producers who ku'i kalo.

#### Is Pa'i'ai or Poi a Potentially Hazardous Food?

Poi is the staple that kept Hawaiians healthy for 1,200 years. Unlike the watered-down version of poi served or sold at tourist lu'au and other establishments, hand pounded poi and pa'i'ai (the thick, delicious precursor to poi) is a delectable food unique to the Hawaiian Islands.

Poi is a naturally fermenting product and because of this, a good source of healthy probiotics, in the same manner as active bacteria yogurts, miso, tempeh, soyu, tofu and natto. Studies have shown that these foods aid in digestion, reduce cholesterol, and the chances of heart disease (Shintani and Hughes 1993). Poi is one of the most hypo-allergenic, low glycemic index, complex carbohydrates you can eat and therefore an excellent food choice for diabetics, a disease that effects more than 110,000 people statewide (DOH 2007; Kaiser 2008). In addition, the act of growing and/or hand pounding taro increases physical strength, burns calories,

improves stamina and circulation. But, is poi also a potentially hazardous food (PHF)?

Only in recent decades, due to more general food safety concerns and rules, has poi landed on the list of PHF along with a requirement to refrigerate pa'i'ai and poi from the time of production through sale on market shelves. Refrigeration slows or kills the natural fermentation process. It can also cause the poi to become hard, requiring resteaming to restore to a smooth consistency.

The unique bacteriocin-producing bacteria which creates the souring element in poi is scientifically recognized as a food preservation element historically and in modern times.

C.S. Stewart, in 1823 wrote "Hard or dry poi [pa'i'ai] is kalo (taro) baked and beaten in the manner described, but not moistened with water... In this manner, it will keep without injury for months; and makes a principle article in the sea stores of the native vessel." The low level of moisture in pa'i'ai, along with bacteriocins, make it an unlikely host for bad bacterial growth.

In 1932, Carey Miller, in Bishop Museum Bulletin 37 (1932) describes this and backs it up with laboratory science. Natural fermentation increases Vitamin A and B levels important in brain and body health and function. Miller records that the "souring process acts...in preventing the development of undesirable bacteria and produces a food that will keep without refrigeration for several weeks" with little change in carbohydrate content. This was reiterated in 2002 under US Patent No 6,753,024 A Method for Making a Food Preservative and for Preserving Food.

To the more general concern of safe food for consumers, Department of Health staff described seven means by which to keep prepared food outside the "window" of potential for harmful bacteria to form, most of which are covered in existing rulings; several of these apply to pa'i'ai and poi.

- 1. Refrigeration (less than 40F)
- 2. Heat (greater than 140F)
- 3. A strong osmotic, like extreme salt (ie. salt fish) or sugar (ie. candied fruit);
- 4. Nitrates;
- 5. Dry (ie. pa'i'ai)
- 6. Low pH values (ie. poi allowed to sour naturally); and
- 7. The consumption of a product within 5-7hrs of production (ie. direct from poi board to consumer).

With millions of pounds of poi made and sold annually in Hawai'i, contamination of poi rarely occurs compared to other foods, and most often after poi leaves the processing plant (Teves, UH CTAHR Extension, 2009). In fact, DOH records over the last 35 years show that for the few cases associated with poi; all were traced to, or were the likely result (although unproven), of food handlers at the restaurants or hotels who mixed and served the poi, including the two most often cited cases in 1972 and 1996 in Lahaina, Maui. No single incident of food borne illness associated with hand pounded poi has been recorded within that same time frame.

Historic record, the oral history of those who pounded kalo before us, and the scientific evidence available supports the removal of poi, a naturally fermenting food, from the DOH PHF list. One need only observe the speed at which hand pounded poi moves from the board to the 'ōpū

(stomach) at demonstrations and cultural events to know it doesn't sit around long enough to become a PHF – and to see how hungry people are for this cherished food as it was meant to be eaten.

Ultimately, knowing a food is handmade within reasonable standards, it becomes the choice of consumers. In this case, there is a resounding preference for unrefrigerated pa'i'ai and poi. Both federal and state law provides the opportunity for exemption from refrigeration. For the state this is a chance to make legal the revival of healthy cultural practices and food preferences in the Hawaiian community. The bill does not increase the burden of DOH staff.

### Economic and Agricultural Impacts of Pa'i'ai

The production/sale of hand pounded pa'i'ai and growing taro for hand pounders represents the restoration of markets that existed prior to the introduction of mechanized mills in Hawai'i. A 1930's Star Bulletin writer observed that "[poi is] the principle dish on the tables of thousands of Hawaiians just as it was in the days before." Poi could be purchased at 127 establishments and served at 77 cafes and restaurants plus 2 hotels in Honolulu alone (Olszewski 2000:72-74).

Despite a long hiatus in local markets, the practice of hand pounding and a desire for pa'i'ai and "one-finger poi" is again at the forefront, like an 'oopu coming home to the stream of its birth.

As a member of the Taro Security and Purity Task Force, I believe that SB101 will help address a number of issues and recommendations found in the 2010 Report to the Legislature, including increasing demand for raw taro and poi, educating consumers and the general public, developing new niche and value-added markets, and providing incentives for our young men and women to return to the growing and production of kalo (whether for subsistence or commercial purposes). This is critically important at a time when jobs, especially in rural communities are scarce. These same issues are reiterated by the Governor in his plans to support small business and local food self-sufficiency.

As a taro farmer, I believe this bill solidly supports the development of a new niche market for raw taro and will encourage more small growers. I have met many young people wanting, or attempting, to return to the lo'i and to the production of poi. The price of raw taro for a full time farmer does not provide enough income to care for a family (under \$0.70/lb at the mill); the result can sometimes be poor choices in seeking supplemental income — or families who hover around the poverty line. A typical taro farmer can't afford health insurance. If we are to make taro farming a desirable vocation again, and to build a future that perpetuates all that is good about taro farming and poi, we need to get serious about supporting opportunities for dignified livelihoods, especially for young families with limited resources.

With this new market, a grower will have a choice to plant or pull taro early specifically for hand pounders (more starch; less sugar) and receive a higher price (\$2-3/lb), and/or pull on his or her regular schedule to provide for conventional millers. In rural districts, being able to pound and sell pa'i'ai at a higher price than poi diversifies and adds value to a currently limited market for taro growers and cultural practitioners and gives them a choice of a much improved farmgate price. As demand for hand pounded pa'i'ai increases it will strengthen the economy and encourage new taro farms and farmers.

Will this negatively impact existing millers? No.

A key amendment in the bill waives the need for refrigeration, an important and necessary change for millers. Hand pounders pay a higher price to growers but demand a better quality taro. This requires change in farm practices. We will have to learn to harvest not for peak size but earlier in a growing cycle for peak weight, to diversify the varieties of taro we grow, and to heal our soils rather than continue with conventional fertilizer applications. This is will lead to better quality taro and higher yields for millers as well as those who ku'i.

To produce pa'i'ai requires physical health and attention to small batches of taro each time. The new market will be limited by taro availability and by the number and stamina of individual hand pounders. This is not a practice for everyone. Because hand pounders buy a more expensive grade of kalo, the price of pa'i'ai will always be higher than milled poi. Rather, traditionally made pa'i'ai will increase awareness of and demand for all types of poi.

Will it negatively impact poi quality? No.

Hand pounded pa'i'ai and milled "pa'i'ai" or poi are not the same product. Already, there are poi products of varying quality on the market. Two years ago, the percentage of water in poi was again raised as an issue by consumers in the legislature. Hand pounded pa'i'ai will raise the bar of poi quality throughout the industry. Consumer awareness will provide an additional check.

SB101 SD1 HD1 resolves the issues and supports the new opportunities described above.

The foresight of Hawaii's State Constitution provides committee members, under Article IX Public Health, Section 9, the means to restore the practice of hand pounding kalo to its rightful place in our community, as an important cultural art, food and income source, as a source of health, and as an important part of Hawaii's movement towards diversifying agriculture, expanding local agriculture markets, and improving local food security and self-sufficiency.

With the passage of SB101, I hope that the quality of taro and pa'i'ai represented at Hawaiian Caucus Day this year will become staple fare legally available to residents throughout the state once again.

I am a proud aboriginal Hawaiian from Ha'iku, Maui. I am currently a PhD candidate at the University of Hawai'i at Manoa Botany Department. I have over \$10,000 of school loans I need to repay. If SB 101 is passed it will allow me to legally make and sell pa'i 'ai to help pay back my expensive student loans. By making and selling pa'i 'ai I can generate enough money to sustain myself financially to survive here in Hawai'i and to help pay off my student loans The money I can generate from selling pa'i 'ai will help me to complete my dissertation on Hawaiian species leaf design and eco-physiology.

There are not that many jobs that we Hawaiian's can get and make enough money to sustain ourselves and our family and go to college. Selling pa'i 'ai and poi is an awesome way to raise funds that is a win win for the producer and the consumer. SB 101 will help to get healthy food to more people to improve Hawaii's health statistics. SB 101 will help support local agriculture which is more sustainable and it will keep more money in Hawai'i. We need more people to grow and make their own food. With the cost of gas increasing it is much more economical to produce healthy food locally, instead of importing food from thousands of miles away to Hawai'i.

I have been making and eating pa'i 'ai along with poi for years and I want my grandchildren to have the opportunity to make and sell pa'i 'ai. I eat my pa'i 'ai and poi the same way my great grandparents enjoyed it. We usually store our pa'i 'ai or poi at room temperature for a few days until it starts to ferment and become more healthy and delicious before we eat it. Our elders call fermented poi stored at room temperature medicine. The oldest pa'i 'ai I have eaten was at least 3 months old. It was stored in simple ti leaves on my kitchen counter. Fermented pa'i 'ai and poi has a wonderful taste and color that my family has enjoyed for hundreds of years.

SB 101 is very important because it gives me the opportunity to continue a traditional Hawaiian practice and be able to sell a healthy product that will benefit the community and Hawai'i's economy. Thank you for your time. Please help support SB 101. Aloha 'Aina. A hui hou,

Christopher Ikaika Duane Nakahashi Ha'iku, Maui Aloha mai e ka alakai o Robert Herkes me ka hope o Bryan Yamane. I am Earl Kawa'a and I <u>support</u> the Legalization of Pa'l'ai' S.B 101.

My connection to kalo goes back twelve generations. As a child growing up in Halawa valley, on the island of Molokai, kalo provided a small income for the family. We, like all the families in the valley, hand pounded and ate poi daily. The water from Moaula waterfall and stream was used to cook kalo, 'ohole, ihi, and pound our poi. Water from the same source was used to ho'owali pa'i'ai, a hard undiluted poi. Everyone in the valley and most of Molokai's residents ate fish and poi. I cannot recall any one on Molokai receiving treatment for eating poi that was pounded under the house, under the mango, olu, hala or kiawe trees or on the lawn at 10am under the blue Halawa Skies.

Among commercially available poi is a brand called Pa'i'ai which is, in fact, machine produced – not hand pounded. It is holowai or hehe'e and therefore, cannot be classified as pa'i'ai. Pa'i'ai is hard, undiluted poi, the fourth stage in the process of converting cooked kalo into poi.

Senate Bill 101 requires no money and is supported by the Department of Health. The state of the economy is poor and many young fathers are without work and seeking employment. Passage of SB 101 will enable many families to fully or partially support themselves via the production of hand pounded poi, a cottage industry.

Aloha mai,

My name is anthony Deluze.

I am a ku'I practitioner (hand pounder), kalai pohaku practitioner (stone carver), part time mahi'ai (farmer), kalo enthusiast born and raised on the windward side of Oahu now living in aiea. I am 30 years old have 2 children and a wife all of hawaiian/polynesian ancestry. we are in full support of SB101.

I have been eating kalo, poi and pa'I'ai my whole life. As well as my children and wife. I ku'I kalo (hand pound) pa'I'ai for my family at least once a week.

Never do we refrigerate our pa'I'ai or poi and have never gotten sick, and I know we never will. We prefer it at room temperature as it attains better quality when it poha (rises and ferments )

Poi and pa'I'ai are unique foods, and considered a healing food. I have been around kalo all my life and remember growing kalo on my own when I was around 8 years old and learning how it is cultivated and when it is ready to harvest.

Today I grow over 50 varietys of hawaiian kalo to help preserve this treasure for the generations to come . Each variety is unique , and does best in different environments and bring a different quality and taste when hand pounded.

I support SB101 because This bill affects many people in hawaii for generations to come.

It supports a cultural practice that has been going on for hundreds of years and will help to instill pride in continuing this cultural practice. The bill defines the terms pohaku ku'I 'ai , papa ku'I 'ai ,and hand pounded poi insuring security to this cultural practice.

In this tough economy it will allow family's to supplement their income legally as long as they meet DOH requirements (protecting the consumer by having to take food safety classes among other requirements).

Moms and dad's unable to afford child care for their children can now create an income while staying home watching their children and have pride knowing they are doing a good thing for their family and community.

SB101 allows the ku'I practitioner to only sell directly to the consumer and not to a establishment that will resale it to a third party , so poi millers will still be doing business as usual selling to markets, restaurants and other establishments.

The bill will help the mahi'ai kalo (kalo farmer) as he can grow more then just one variety of kalo (certain kalo is adapted and grows better in certain environments then others) which is more economic because having a variety that grows better in your locality will decrease the use of heavy fertilizing and the use of cross breeds that may be stronger but inferior in quality and taste. Right now only a few kalo's are grown on a big scale.

It will also help us to keep our varietys alive because all these varietys can be hand pounded and different varietys are preferred and encouraged, while only select varietys with one variety dominating are preferred for milling.

This bill encourages a new venue to build a self sustaining economy for hawaii by encouraging more farmers to grow kalo and current farmers to diversify the kalo they grow.

They will be able to sell to the millers as well as the hand pounders creating new revenue to support their family's. The current price being paid for kalo is around 60cents a pound, hand pounders are paying up to \$2 a pound for kalo but is required to be of higher quality and more starchier. (As starchier kalo is needed to hand pound pa'I 'ai and poi)

SB101 will allow hand pounders to create revenue to support their family's. This is economy stability.

Another important amendment of the bill allows for poi to be legally stored at room temperature, which benefits every one, consumer, producer mills and hand pounders alike. This bill will not cost the state a thing but the people of hawaii will benefit greatly from it.

Please legalize pa'I'ai. Its our food, its our work, its our culture and its our right.

#### Aloha mai kakou,

SB101 has widespread support from, ku'i'ai (hand pounding) practioners, taro farmers, poi millers, health practioners, public servants, professionals, educators, small businesses, parents, youth, kupuna, cultural practioners, etc. and many organizations. SB101 is a good solid bill, beneficial to all. I fully support SB101 for the following reasons:

- 1. The existing Department of Health (DOH) regulations are presently too narrow to encompass traditional ku'i'ai (hand pounding), so change is needed.
- 2. SB101 is the result of our collaboration w/Department of Health (DOH) to make appropriate changes so traditional ku'i'ai can be appropriately regulated. We have DOH support.
- 3. SB101gives consumers the right to buy traditionally made poi and pa'i'ai.
- 4. It protects consumers by requiring the following: a producer must attend the DOH food safety class, have a hand wash station on site, label the pa`i`ai/poi with their name and have visible signage that says, "this product was not made in a DOH certified facility." The consumer requests and buys fully informed.
- 5. Informed consumer choice to purchase protects the DOH/state from liability. The DOH continues to have inspection rights. If complaints are made the DOH can fine and shut down a producer.
- 6. SB101enables a person to ku'i'ai and sell legally once they have met the appropriate DOH requirements. It is for small operations only. It supports cottage industry, stay at home moms and dads, taro farmers who want to make a value-added product, youth making their own cultural livelihood, schools/organizations who want to fundraise with a healthy cultural product.
- 7. The definitions of Hand-pounded, Hand-pounded poi, Pohaku ku`i`ai, Papa ku`i`ai now in the bill insure cultural integrity.
- 8. SB101enables practioners to make a livelihood doing what they love to do-feed our people the best mea ai possible. This is cultural perpetuation.
- 9. Because a ku`i`ai practioner can only ku`i starchy taro and will pay more for starchy taro (at least double what the mills are paying), the rise of ku`i will create more income for taro farmers, thus strengthening that economy, will cause more people to grow taro as a livelihood, thus strengthening our community food security, and will increase the availability of an extremely healthy food for the general population, thus increasing health and decreasing sickness- this will save the State money.
- 10. The rise of ku'i'ai will positively impact the existing poi companies by: increasing the awareness, visibility and value of poi, by increasing the starchy quality of taro- which results in a greater yield of poi per lb of taro- thus increasing their profits.
- 11. In addition, one of the key amendments that is in the present version of SB101 allows poi to be stored at room temperature. Presently the DOH is federally mandated to classify poi as a

"Potentially Hazardous Food". One result of this classification is that legally, poi needs to be refrigerated. Presently most poi is not refrigerated and is in violation of DOH regulations. We all know that poi does not need refrigeration and it is the furthest thing from a hazardous food. With the passage of SB101 with the above amendment our common, cultural and historical practice of poi storage will be legal. This is key for all consumers, stores and producers of poi, especially the mills.

- 12. The executive summary of the Governors' comprehensive plan "A New Day in Hawaii", proposes to support small business, increased local food production and consumption and restore public confidence in government. SB101 realizes these proposals.
- 13. SB101 is a no cost bill to the State. It will enable the growth of grassroots livelihood.
- 14. Please pass the bill out it in its present form.

I am the great grandson of Washington states' founding fathers' of Kalama Valley and council member of the Nisqually Tribe here in Yelm, WA. I am writing you today in support of SB101. Our connections are deeply rooted in Hawai'i though our traditional practice are predominately based on our Nisqually heritage, my people and I honor my great grandfather John Kalama and his family legacy every day.

If Kalo could be grown and managed here in the state of Washington we would have no problem with the state and the department of health in legalizing the sale of Pa'i'ai and keeping the traditional preparations and makings, the same way our ancestors and relatives did and continue to do today. I understand the laws are different for each state but with this bill moving forward and becoming a law, we are hoping the same could be done for the farmers who choose to prepare poi the traditional way as my great grandfather and his family did before they came to the Pacific Northwest. These are practices that should be respected and upheld with no question. They should also have the choice to sell Pa'i'ai with the proper steps taken such as food handlers permits and certification through the state of Hawai'i and Department of Health.

Our first experience with traditional poi making took place 20 years ago, each year we have gone back to Hawai'i and have spent months eating Pa'i'ai each day that we spent there. Though we could not take Pa'i'ai home with us and if our friends and other tribal members wanted to purchase Pa'i'ai from our relatives and local farmers' that specialize in this, we could not honor them or respect our culture by purchasing it, because it was illegal. So this has been a continuing fight for us as Native American's and Native Hawaiians.

With our nation growing strong with over 500+ we would like a better source of nutrition that would help our children into their future and our elders that are with us now. With my family alone there are 15 total in support of passing this bill, SB101. I'm writing to you today to <u>support</u> SB101 and legalize the sale of Pa'i'ai. There are many benefits to the traditionally pounded poi, not just for an individual but a culture as a whole. The state is so worried about the tools getting contaminated due to the porous texture of the pounder but anyone who has enough respect for the culture to continue Pa'i'ai should also show that same respect to sterilizing it in the traditional way, learning the traditional cleansing techniques is part of learning how to pound it.

In the long run the poi that is produced this way has a much longer shelf life (days, weeks, months, even years longer) than the store bought that comes in plastic bags, which has to be used within a week after leaving the store. The plastic also can't be recycled so if the poi goes bad, the plastic as well as some of the product, ends up in landfills. Factories also have a long history of screw ups. Yes, over the century or two they have come a long way but if they happen to make a little slip in one batch and don't catch it, there mistakes become wide spread. People have a better chance of getting sick off of factory poi that has gone bad than getting bad Pa'i'ai, especially when it is cleaned traditionally.

Just ask anyone who has tried both factory manufactured as well as traditionally produced, it is the traditional that wins on taste. However, taste and shelf life alone is not enough reason to legalize it, Pa'i'ai also brings the culture together. Poi is such a staple in Hawaiian life that families connect over it at dinner, it connects them to who they are as a people, and it connects them to their past. Connecting over soupy, factory processed, short shelf life mush connects them to nothing. Don't let the culture mirror what has become of today's poi, and legalize Pa'i'ai. Too many cultures have disappeared over time because someone who doesn't know any better has deemed their ways as unhealthy or dangerous. We know better, Thank you for your pledge to hear the bill SB101.

Regarding - SB 101, RELATING TO HEALTH, which would exempt producers of hand-pounded pa'i 'ai from having to use certified kitchens or getting a DOH permit if they comply with product labeling and other conditions. The bill would also subject producers of pa'i 'ai, which is hand-pounded kalo undiluted with water, to inspection by DOH.

### I support SB101.

Hand pounding pa'i'ai and poi has been a traditional Hawaiian cultural practice and means of making and preserving food for at least 1,200 years. In that time, it fed a nation of hundreds of thousands of people and kept them well. In 1852, the Department of Interior recognized the making of poi as "a method for preserving kalo...in common use on these islands from time immemorial" (Int.Dept. Bk.6.p.22.1852.Sept15). Today, people continue to honor the practice of hand pounding poi and to pass that on to successive generations as a valid means by which to feed a family and a community.

These traditional staple foods, in this time of community food security and epidemic health crisis, are once again regaining recognition and popularity as some of the most healthy and secure foods in today's modern landscape.

Our traditions hold that kalo is the elder sibling of the Native Hawaiian people. Poi, which is made from kalo, is the staple of our traditional diet. While poi mills have provided our communities with poi for many years, the traditional practice of hand pounding poi is enjoying a powerful resurgence today. We must nurture this movement, as it supports our local agricultural industry, ensures food security and promotes a healthier diet, all while encouraging one of our most important Native Hawaiian cultural practices.

The choice of an individual to make a livelihood born of this traditional practice is not an easy one. Production is limited by physical endurance. To carry this work forward during the economically difficult times of today is a demonstration of strength and resiliency that we all have within us and should encourage and support. With a stone and a board and good kalo. one can make a living that both honors Hawaiian culture and invests in the future - of their family and of taro farmers.

The Hawai'i State Constitution Article I X Public Health Section 9 provides that "the State shall have the power to preserve and develop the cultural, creative and traditional arts of its various ethnic groups" «(onCon1978); thereby, giving the legislature the authority to support SB101 and recognize the making of pa'i'ai and poi using traditional hand pounding methods as a cultural and traditional art, with the sale of that product as an extension of that development.

SB101 allows this practice to become an economically viable and dignified way to make a living without undue economic burden on small cottage industry producers of hand pounded poi.

The legislature experienced the resounding beat of the pohaku ku'i ai rising from the Rotunda earlier this month. Many of you joined us and experienced the aloha and the sharing of pa'i'ai that occurred throughout the day. Hearing the beat of the stones in neighborhoods and valleys all over the islands again is to hear the sound of a healthy and food self-sufficient community — a means to sustainability for all of Hawai'i.
