TESTIMONY ON SENATE BILL NO. 1522, S.D. 2, RELATING TO DOGS.

**TO THE HONORABLE ANGUS L. K. MCKELVEY, CHAIR,
AND MEMBERS OF THE COMMITTEE:**

My name is Celia Suzuki, Acting Licensing Administrator of the Professional and Vocational Licensing Division, Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to testify on Senate Bill No. 1522, S.D. 2, Relating to Dogs.

Senate Bill No. 1522, S. D. 2, creates a new chapter to regulate large scale dog breeders. Section 26H-6, Hawaii Revised Statutes, requires that new regulatory measures being considered for enactment be referred to the Auditor for a sunrise analysis before any measure is enacted. The statute further requires that the analysis

shall set forth the probable effects of regulation, assess whether its enactment is consistent with the legislative policies of the Hawaii Regulatory Licensing Reform Act, and assess alternative forms of regulation.

Therefore, the Department strongly supports a sunrise study on this measure, as mandated by law, before regulating large scale dog breeders. Thank you for the opportunity to testify on Senate Bill No. 1522, S.D. 2.

On behalf of our more than 49,400 members and supporters in Hawaii, we thank the Committee for considering this important measure to protect both dogs and consumers. Our organization has been involved in efforts in sixteen states that have passed similar laws in the past 2 years to prevent the cruel treatment and exploitation of dogs, where sadly, profit is all too often put above welfare.

The purpose of this bill is to require that large-scale dog breeding operations be licensed and provide each dog under their care with basic food and water, adequate shelter from the elements, necessary veterinary care, adequate space to turn around and stretch his or her limbs, access to space for critical exercise and adequate rest between breeding cycles. These most basic requirements are found in a number of state laws, but sorely lacking in Hawaii.

Animal Welfare Concerns:

Dogs at puppy mills, also known as large scale commercial breeding operations, typically receive little to no medical care, often live in squalid conditions with no exercise, socialization or human interaction and are confined inside cramped wire cages for life. Breeding dogs must endure constant breeding cycles and are typically confined for years on end, without ever becoming part of a family. The breeding "stock" live their entire lives confined to small cages, devoid of human companionship. They are often victims of filth, inadequate shelter, overcrowding, and insufficient food and water. They are bred repeatedly and often receive little or no veterinary care.

Furthermore, many of these large-scale dog breeding operations continue to produce litter after litter of puppies, exacerbating the pet overpopulation crisis; contributing to increased euthanasia rates at local animal shelters and increasing animal care and control costs for taxpayers.

Consumer Protection Concerns:

Dogs from these large-scale breeders are often sold in pet stores, online, via newspaper ads and in some cases directly to consumers with little to no regard for the dog's health, genetic history or future welfare. Puppies are often taken from their mothers for sale to pet stores at approximately 8 weeks of age, when they are highly susceptible to contagious diseases such as parvovirus and

are very sensitive to behavioral stress. Poor breeding practices can also lead to serious genetic problems such as hip dysplasia—an often painful and crippling disorder.

In addition, many unknowing consumers also purchase dogs with “Registry Papers” thinking that this ensures the health or temperament of the dog they are purchasing. However, the American Kennel Club (AKC), by its own admission, has stated that AKC papers, “in no way indicate the quality or state of health of the dog.” No one should believe a dog is well-socialized, genetically sound, or healthy simply because he or she comes with registry papers. In several states, laws even mandate that consumers must be told that these registry papers do not guarantee health or even lineage. Unfortunately, consumers mistakenly believe that a high price for a dog means that the dog is healthy and well-socialized,

Again, we urge your support of SB1522 and these most basic requirements to better protect dogs and consumers alike.


The act would regulate businesses that have 20 or more intact female dogs over the age of six months; or who have a total of 30 intact dogs that are 6 months or older; or sells 25 or more puppies within a year; with no more than 50 intact adult dogs on any property at any time.

These large scale breeders would be required to be licensed and this Bill establishes minimum standards of care that includes: veterinary care, maximum allowed breeding within an 18 month period, space requirements, exercise and access by inspectors at any reasonable time during regular business hours.

We ask for your strong support of SB 1522, SD 2.

Dear Chair McKelvey, Vice Chair Choy and Members of the Economic Revitalization & Business Committee,

I strongly **support** the passage of SB 1522 in its amended form regarding the regulation of large-scale commercial dog breeding in Hawai'i.

The purpose of this bill is two-fold: to protect the interests of consumers and the interests of the animals. With no state law currently regulating these types of commercial breeders, consumers can unknowingly purchase a dog from a business that treats animals as mere commodities. The result can be hidden medical or behavioral problems, including problems resulting from years of inbreeding, which end up costing the consumer more than they bargained for.

The act would regulate businesses that have 20 or more intact female dogs over the age of six months; or who have a total of 30 intact dogs that are 6 months or older; or sells 25 or more puppies in a year. These large scale breeders would be required to be licensed and inspected, and this bill establishes minimum standards of care for the animals that include: veterinary care, maximum breeding within an 18 month period, size-specific space requirements, minimum daily exercise, and access by inspectors at any reasonable time during regular business hours.

I ask that you support the passage of SB 1522. I strongly believe that the passage of this bill is a necessary step to take in order to improve the lives of animals in Hawaii, and I urge you to support the passage of SB 1522 relating to the regulation of large-scale commercial breeding of dogs.

Representatives McKelvey, Choy, and Members of the Committee,

I am writing in support of SB298 SD3, the bill that establishes a framework for the establishment of the Sustainable Business Corporation in Hawaii. There are many reasons why this type of corporate structure is good for Hawaii and good for business. Businesses that benefit the community by operating in a socially and environmentally responsible manner increase customer loyalty, which makes good business sense as they prove their worthiness to the public beyond merely the products and services they provide. Such practices have been shown in research to contribute positively to profitability. Under this legislation, these entities will formally agree to operate for the public benefit as follows:

- (1) Providing low-income or underserved individuals or communities with beneficial products or services;
- (2) Promoting economic opportunity for individuals or communities beyond the creation of jobs in the normal course of business;
- (3) Preserving the environment;
- (4) Improving human health;
- (5) Promoting the arts, sciences, or advancement of knowledge;
- (6) Increasing the flow of capital to entities with a public benefit purpose; and
- (7) The accomplishment of any other particular benefit for society or the environment.

Sustainable business corporations exist to serve the interests of multiple stakeholders: shareholders, employees, customers, communities, and the environment. In demonstrating care for these stakeholders, I believe that public benefit corporations will be more successful businesses, which will encourage the entire business community to consider similar practices.

As this is a voluntary standard, obviously it is meant for those conscientious businesses that wish to embrace this high level of transparency and accountability. I urge the Committee to enable such businesses to strive for this level of integrity, and as such I urge you to support SB298 SD3 to raise the bar for business standards here in Hawaii.
