SUBJECT: **S.B. 900, S.D. 2 - RELATING TO HOMELESSNESS**

Hearing: Wednesday, March 16, 2011; 10:00 a.m.

PURPOSE: The purpose of S.B. 900, S.D. 2, is to establish the Hawaii interagency council on homelessness under the Department of Human Services for administrative purposes and makes an appropriation for administrative expenses.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the overall concept of this bill as it includes initiatives supportive of our goals and objectives but we are concerned about the cost implications generated by this proposal.

President Obama has renewed the effort to empower the United States Interagency Council on Homelessness through which the State of Hawaii is affiliated via the Region 9 Federal governance.

The establishment of a Hawaii interagency council on homelessness will allow the State to collaborate with the jurisdictional Interagency Councils across the nation to continually fine tune the effort to end homelessness. The United States Interagency Council on Homelessness recommends that the States establish such a State agency by legislative action or executive order, or both.

The appointment of Marc Alexander as the Governor's Coordinator on Homelessness, to spearhead homelessness collaborations across federal, State and County jurisdictions and with community and businesses partners, is an excellent starting point to revisit the State's Strategic Plan to End Homelessness and to provide the statewide collaboration needed to address homelessness issues through the backing of the Governor's Office.

Thank you for the opportunity to provide comments on this bill.

Madam Chair and Members of the House Committee on Housing and Mister Chair and Members of the House Committee on Human Services, thank you for the opportunity to provide you with comments regarding Senate Bill 900 as amended by Senate Draft 2, relating to homelessness.

The Hawaii Public Housing Authority (HPHA) supports this measure, which would re-establish the Hawaii Interagency Council on Homelessness. However, the HPHA respectfully requests the Committees to amend this measure to refer designating authority of an HPHA representative from the Director of the Department of Human Services (DHS) to the Executive Director of the HPHA. The HPHA is attached to DHS for administrative purposes only; as such, the designation of a qualified representative from the HPHA's staff is a decision more appropriately within the purview of the HPHA's Executive Director, who provides day-to-day management of staff responsibilities.

The HPHA appreciates the opportunity to provide the House Committee on Housing and the House Committee on Human Services with the agency's position regarding S.B. 900 S.D. 2. We respectfully request the Committees to amend this measure appropriately and pass it favorably.

Thank you for the opportunity to provide testimony on SB 900 SD2, which would establish the Hawaii Interagency Council on Homelessness. I am Betty Lou Larson, Legislative Liaison for housing and homeless issues at Catholic Charities Hawaii. Catholic Charities Hawaii supports the intent of this bill, with the following amendments:

Suggested Amendments:

1. Add the Office of Hawaiian Affairs and Department of Hawaiian Homelands.
2. Add the Leeward Housing Coalition.
3. Delete funding for administrative expenses.

This new Council is an exciting initiative to forge partnerships to end homelessness. It will work to form a unified plan to address homelessness across the State. All parts of our community need to be involved to resolve this sometimes overwhelming social problem. This Council will create one important process to form partnerships and linkages to achieve effective outcomes. It is not the only one, since business and other groups need to be involved but in other perhaps more informal ways.

We suggest that the Legislature delete the funding for administrative purposes. With very limited funds this year, we urge that the scarce funding available should focus on maintaining the direct services of homeless programs.

Thank you for hearing our testimony and especially for your concern and your support to end the crisis in homelessness. In these difficult economic times, we appreciate your dedication to continue to seek solutions to the homeless problems of our State.

I am Myoung Oh, Government Affairs Director of the Hawai'i Association of REALTORS® ("HAR"), the voice of real estate in Hawai'i, testifying on behalf of its 8,500 members. HAR **supports** of S.B. 900, S.D. 2, establishing the Hawai'i Interagency Council on Homelessness under the Department of Human Services.

There are approximately 6,000 homeless living in Hawai'i, and it is of serious concern to many communities and residents throughout this State. Furthermore, the high cost of housing and living, here in the islands, may make it difficult for struggling families trying to make ends meet to be able to afford the opportunity to own, or even rent a home.

HAR has historically supported mechanisms to help increase the supply of low and moderate income affordable rental housing, such as the Rental Housing Trust Fund Program, which helps provide these opportunities.

HAR is supportive of the endeavor to create a Hawai'i Interagency Council. Moreover, HAR looks forward to assisting with the formation and coordination of a unified plan to help address homelessness in all counties, and assist in facilitating the acquisition of federal funding for homeless programs.

We testify in regards to SB897 SD2, RELATING TO HOMELESSNESS and SB900 SD2, RELATING TO HOMELESSNESS, which would both establish the Hawaii interagency council on homelessness. Helping Hands Hawaii (HHH) *supports* both bills, *with suggested amendments*.

HHH is a 501(c)(3) non-profit social service agency, which was incorporated in 1974. HHH administers a variety of Behavioral Health and Human Services programs, which assist over 37,000 individuals and households each year.

Both our Behavioral Health and Human Services programs provide a wide range of services intended to prevent homelessness in Hawaii. Our agency provides case management services for adults with serious and persistent mental illness, including many who are currently homeless, and also provide case management specifically for Mental Health Kokua's Safe Haven Project in Chinatown. In addition, our agency also offers emergency financial assistance to help

individuals who are homeless to obtain and maintain long-term housing through our Emergency Assistance Fund and Homelessness Prevention & Rapid Re-Housing Program.

HHH supports both SB897 SD2 and SB900 SD2, which would both establish the Hawaii interagency council on homelessness. HHH believes that homelessness is a concern that affects every member of our community – either directly or indirectly – and therefore all segments of our community will need to be involved in order to develop and implement viable and compassionate solutions to the problem of homelessness. The proposed interagency council on homelessness will bring members of our community together and will help to foster collaborative solutions.

However, HHH would prefer that the Legislature pass SB 897 SD2, which does not include any appropriation for administrative expenses. In addition, HHH suggests the following amendments to SB897 SD2:

- Add the Governor’s Coordinator on Homelessness to the list of members; and
- Change the effective date to effective upon approval.

HHH believes that the newly appointed Governor’s Coordinator on Homelessness can and should play a lead role if the interagency council on homelessness is established. We also believe that the establishment of the council is important, and should be established quickly so that the council can begin to implement potential solutions to address the concerns of homelessness in our community.

In these difficult economic times, HHH recognizes that there is only a limited amount of State funds available, and that funds should be designated to maintaining existing direct services if at all possible. Although HHH understands the rationale behind including an appropriation for administrative expenses associated with the council in SB900 SD2, HHH also believes that the interagency council on homelessness would still be able to achieve its stated goals and purpose even if an appropriation is not included. The members of the interagency council on homelessness would be unpaid, and administrative expenses for travel costs could be limited by exploring alternate meeting options, such as videoconferencing or meeting via webinar.

Once again, HHH is in support of SB900 SD1 with the suggested amendment mentioned above.

COMMENTS IN SUPPORT OF SB 900, SD2: ESTABLISHING THE HAWAII INTERAGENCY COUNCIL ON HOMELESSNESS

Chair Cabanilla, Chair Mizuno, and Members of the Committees on Housing and Human Services:

Thank you for the opportunity to submit testimony on SB 900, SD2, which establishes the Hawaii Interagency Council on Homelessness and makes an appropriation for administrative expenses. Partners In Care supports the intent of this bill on the condition that no funds are reallocated from the budgets of current homeless services or programs. We propose amendments.

Suggested Amendments:

1. Add to the designated entities to sit on the Interagency Council: the Office of Hawaiian Affairs; Department of Hawaiian Homelands; Leeward Housing Coalition; Department of Land and Natural Resources; and the City and County of Honolulu Office of Housing.
2. Delete funding for administrative expenses.

More coordination among entities is needed to improve the delivery of homeless services in our state. Partners In Care, as a consortium of service providers from across O'ahu, advocates on behalf of a diverse population of homeless men, woman and children. It is among the entities that would be required to sit on a Hawaii Interagency Council. The U.S. Interagency Council on Homelessness has recommended that the States establish similar bodies by legislative action or executive order, or both. The recent appointment by the Governor of Mr. Marc Alexander as the state Coordinator on Homelessness has helped to drive the discussion in the right direction. We applaud the state government's efforts to address the problem of homelessness. However, monies for current homeless programs must not be diverted to meet the needs of such a body.

We urge the Legislature to support the intent of this bill on the condition that funds are not diverted from other programs to meet the costs of a state Interagency Council.
