I can only speak to you from the perspective of a social worker and a mother. From a mother's perspective, I observe other mothers - a cat, a dog, a pig, a human or a duck. They care for, feed & protect their babies. All animals enjoy life as you & I do & as they were made to do. They run, they socialize, they love, they live in their own ways. They also feel - and they hurt.

Many years ago, I lost my mother to colon cancer. Then in 1998, my son died in an accident. Pain went through my body like no one should know. Anyone who has gone through a loved one's death knows how devastating that is. In 1998, I promised myself I would not contribute to another animal's pain: I became vegan.

From the perspective of a social worker, I empower people to care for themselves - because I care. My educational background also includes studies in nutrition and biology. Because I am vegan, I probably have a lower cholesterol level than most of you - and at a lower risk of a heart attack or developing cancer.

Because i am vegan, I contribute less to the pain & suffering in the world - than many of you.

Imagine this: Someone just stuck a tube down your throat and your insides just blew out ~

You ask yourself:

Why is life so cruel? What have I done to make life more bearable for all beings - not just humans? It is the humans' responsibility to care for all the beings on this earth?

Why do only some people seem to care ?
