I. Background and Summary

1. A brief description of the applicant's background;

In October 1928, Central Union Church Preschool and Kindergarten opened its doors to l4 children, pioneering the concept of cooperative play school experiences. Over the past 84 years, the school has grown to be one of the largest preschools in Hawaii and a leader in the field of early education. A dedicated and highly trained faculty works together to support the school's mission and philosophy.

School Mission: Central Union Church Preschool and Kindergarten is a Christian-based early education program that promotes spiritual, cognitive, socioemotional and physical growth in a nurturing environment and provides a solid foundation for early learning. Its program of educating the whole child promotes a life-long enthusiasm for learning and provides a smooth transition from home to school. It promotes the value of early childhood education throughout the community and provides for the on-going growth of its faculty and parent community.

Students: The student body is comprised of approximately 188 students from toddlers through pre-Kindergarten. Each year the school receives 250-300 applications for 80 available spaces in the 3-6 program. The Toddler Program for 2 year olds receives approximately 100 applications for 18 available spaces.

Faculty and Staff: There are two teachers per classroom and the teacher to student ratio is no more than 1:10. The faculty is well qualified in early childhood education and is committed to providing a quality program for children. The school offers a Professional Development Program to encourage faculty to pursue college-level degrees in Early Childhood Education. There are 37 faculty and staff.

Central Union Church Preschool and Kindergarten is licensed both by the State Department of Human Services and the Hawaii Council of Private Schools. It is also accredited by the National Association for the Education of Young Children (NAEYC) and is a member of the Hawaii Association for the Education of Young Children (HAEYC) and the Hawaii Association of Independent Schools (HAIS).

2. The goals and objectives related to the request;

In the early 2000's, the preschool council embarked on a phased campus redevelopment project to create a new campus and to enable best practices in early childhood education

The newest campus building was built in the 1950s and designed for older children. The other buildings date back to the 1920s. These structures were originally built as guest pool cabanas on the site of the former Dillingham residence and farm, and are in serious need of replacement. The buildings are no longer suitable for existing academic and administrative functions, the classrooms are undersized and awkwardly configured, there is a lack of storage and teacher support areas and there are no attached restroom facilities. Currently, the administration offices lack waiting space and a private area for the Director to meet with parents and staff.

Finally, a devastating fire in October 2008 destroyed the Nursery Court Building, which housed three classrooms for three-year olds, the development office, administration offices, teachers' lounge and prep room, and restrooms. Since then the school has had to accommodate students in makeshift classrooms.

The architectural firm, Group 70 International, has been retained to conduct the project planning and design. Plans call for a complete rebuilding of the existing campus to be completed in four phases so as to cause minimal disruption to campus life. Project expenses for all four phases are estimated at \$11 million.

The project will include demolition of existing buildings; infrastructure for the campus (sewer, water, electricity, etc); construction of eight classrooms, an administrative building that will include the library and the kitchen.

All of the buildings will be LEED Silver certified making the school the first private preschool campus in the State of Hawai'i to be completely LEED certified.

Groundbreaking ceremonies were held on September 28, 2011 and construction on Phase I began in late 2011. Phase I will be completed by Fall 2012. Ralph S. Inouye, Co., Ltd. is the contractor.

3. State the public purpose and need to be served;

The first years of a child's life are critical to his or her development. Research shows that high quality education before a child turns five yields significant long-term benefits. The "High/Scope Perry Preschool Project," tracked low-income children from the age of two or three through adulthood, and found that individuals enrolled in a quality preschool program ultimately earned up to \$2,000 more per month than those who were not enrolled in the program. Those enrolled were more likely to graduate from high school, to own homes and have longer marriages.¹

Early childhood education makes good economic sense. In 2003, Art Rolnick, a senior vice president and director of research of the Federal Reserve Bank of Minneapolis, received national attention for a paper he published estimating the return on investment of a good preschool at 12%. By 2007 he had revised this return up to 16%.²

In Hawaii each year there are as many as 6,000 new kindergarten students who haven't attended preschool, parent-participation preschools or other home-to-school transition programs that help prepare children for a successful school experience. According to the Good Beginnings Alliance, "Four out of every 10 children come into kindergarten not prepared and then they have to catch up, which very often doesn't lead to a good start for the child." 3

Quality early childhood education facilitates a gentle transition from home to toddler care, preschool, junior kindergarten, and on to kindergarten and formal education. In addition to a caring and experienced faculty and staff, the active participation of parents and collaborations in the community, quality early childhood education is enhanced by a well- planned and welcoming environment that includes outdoor play areas and home-like interior activity areas.

4. Describe the target population to be served; and

Children of all races and creeds are accepted at Central Union Church Preschool and Kindergarten. The student body is comprised of approximately 188 students from toddlers through pre-Kindergarten. Each year the school receives 250-300 applications for 80 available spaces in the 3-6 program. The Toddler Program for 2 year olds receives approximately 100 applications for 18 available spaces.

Central Union Church Preschool and Kindergarten serves families throughout the island of Oahu.

II. Service Summary and Outcomes

1. Describe the scope of work, tasks and responsibilities;

Group 70 International is working on Phases I thru IV with construction of Phase I provided by contractor Ralph S. Inouye, Co., Ltd. Phase I construction started in late 2011 and will be completed in Fall 2012.

Phase I construction includes initial installation of infrastructure (sewer, water, electrical lines); construction of Classrooms 1 & 2; and construction of the Library and Administrative building.

Planning and the projected timeline for subsequent phases are as follows:

- Phase IA and II: The Bam, Infrastructure and Classrooms 3 & 4 completion Fall 2014
- Phase III: Kitchen; Classrooms 7 & 8; Gardens Entry completion mid-2015
- Phase IV: Classrooms 5 & 6 completion Spring 2016

Oversight and management of the project will be maintained by contractors, architects, construction project management team, select preschool council members, the Director of Central Union Church Preschool and Kindergarten, and the Owner's Representative Committee chaired by council member Howard Green, an attorney and developer. The Owner's Representative Committee members include the Council's treasurer, members from the Building and Grounds Committee, the Preschool and the Church's administrator and comptroller.

The campus redevelopment project will be evaluated through the systems that currently evaluate the school: 1) The Department of Human Services, State of Hawai'i; and 2) national accrediting bodies including the National Association for the Education of Young Children (NAEYC), both of which conduct rigorous quality reviews of educational programs, faculty qualifications and facilities requirements.

Additionally, the project and the Capital Campaign will be evaluated based upon meeting the projected construction and campaign timelines and budget. Both the Church and School are financially stable and perform an annual audit. Central Union Church Preschool and Kindergarten has experience in grants management, having received a State Grant-in-Aid (GIA) for plumbing and electrical upgrades, grants from private foundations.

Central Union Church is governed by a24-member Church Council, made up of individual volunteers from a wide range of backgrounds. Four members of the Church Council also serve on the Preschool Committee, which acts as liaison between the Council and the Preschool Ministry. The Preschool Ministry consists of 16 voting members who are responsible for the governance of the school.

The Church Council has formed an Owner's Representative Committee chaired by council member Howard Green, an attorney and developer. Committee members include the Council's treasurer, members from the Building and Grounds Committee, the Preschool and the Church's administrator and comptroller. This committee is responsible for decisions regarding the campus redevelopment project and interacts with the project manager and contractor.

In addition, the school has retained the services of the following companies to assist in managing and overseeing the project or to provide construction services:

- Group 70 International architect
- Ralph S. Inouye Co., Ltd. contractor (Phase I)
- Bowers & Kubota project manager




Central Union Church campus is located on 8 acres of property bordered by Beretania and Punahou Streets in Honolulu. Central Union Church Preschool and Kindergarten is situated on 3 acres of the campus. The preschool currently consists of three structures that house 7 classrooms and the school kitchen. Three classrooms and the preschool offices are currently housed in temporary church space, due to a devastating fire in October 2008.

There are three structures on the preschool campus that date back to the early and mid 1900s. These structures occupy approximately 2/3 of the preschool campus. Two of the single story structures are built of redwood and the third is cement. The cement structure is home to two classrooms and was built in 1950 to educate older children. It has not undergone any significant renovations since 1950. The wooden structures were built well before 1950 and are home to 5 classrooms and the preschool kitchen. The single story buildings have open beam ceilings and concrete floors. Classrooms in the buildings average 850 square feet. Restrooms were added onto the wooded structures sometime in the 1940s.

DECLARATION STATEMENT APPLICANTS FOR GRANTS AND SUBSIDIES CHAPTER 42F, HAWAI'I REVISED STATUTES

The undersigned authorized representative of the applicant acknowledges that said applicant meets and will comply with all of the following standards for the award of grants and subsidies pursuant to section 42F-103, Hawai'i Revised Statutes:
