RELATING TO COLLECTIVE BARGAINING COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. There are appropriated or authorized from the sources of funding indicated below to departmental administration and budget division (BUF 101) the following sums, or so much thereof as may be necessary, to fund for fiscal biennium 2011-2013 the salary increases and other cost adjustments related to "favored nations" provisions in the supplemental agreement negotiated between the University of Hawaii and the exclusive bargaining representative of collective bargaining units (2), (3), (4), and (8) for employees of the University of Hawaii:

7 sources of funding indicated below to departmental
8 administration and budget division (BUF 101) the following sums,
9 or so much thereof as may be necessary, to fund for fiscal
10 biennium 2011-2013 the salary increases and other cost
11 adjustments related to "favored nations" provisions authorized
12 by chapter 89C, Hawaii Revised Statutes, for state officers and
13 employees excluded from collective bargaining who belong to the
14 same compensation plans as those officers and employees of the
15 University of Hawaii, within collective bargaining units (2),
16 (3), (4), and (8):

4 SECTION 5. There are appropriated or authorized from the
5 general fund to the Hawaii employer-union trust fund the
6 following sums, or so much thereof as may be necessary, to fund
7 for fiscal biennium 2011-2013 the Hawaii employer-union health
8 benefits trust fund costs contained in the supplemental
9 agreement negotiated between the University of Hawaii and the
10 exclusive bargaining representative of collective bargaining
11 unit (8) and authorized by chapter 89C, Hawaii Revised Statutes,
12 for state officers and employees excluded from collective
13 bargaining who belong to the same compensation plans as those
14 officers and employees within collective bargaining unit (8):

17 SECTION 6. Funds appropriated or authorized by this part
18 shall be allotted by the director of finance to the University
19 of Hawaii for expenditure in the respective fiscal year for the

2 SECTION 7. Salary increases and cost adjustments provided
3 in this Act for any officer or employee whose compensation is
4 paid, in whole or in part, from federal, special, or other funds
5 shall be paid wholly or proportionately, as the case may be,
6 from the respective funds.

7 SECTION 8. Funds appropriated or authorized by this Act
8 that are not expended or encumbered by June 30, 2012, and June
9 30, 2013, of the respective fiscal years, shall lapse as of
10 those dates.

11 SECTION 9. This Act shall take effect upon its approval
12 and shall apply retroactively to July 1, 2011.
