A BILL FOR AN ACT

RELATING TO AGRICULTURE INSPECTORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that support for the
2	biosecurity program under the department of agriculture is
3	important because of the impact of invasive species to Hawaii's
4	agriculture, environment, natural resources, public health, and
5	economy. The legislature also finds that the United States
6	Department of Agriculture and other states' departments of
7	agriculture also face shortages in agriculture inspectors.
8	Therefore, to improve the effectiveness of the biosecurity
9	program, the legislature finds that providing the state
10	department of agriculture with the authority to establish,
11	maintain, and enforce compliance agreements with federal or
12	other state departments of agriculture will allow the federal
13	and other state departments of agriculture and their respective
14	inspectors to work cooperatively with Hawaii's agriculture
15	inspectors on import and export programs.

16 The importation of christmas trees is considered a high 17 risk for introduction of invasive species into the State. This 18 measure would allow the Hawaii department of agriculture to HB2244 CD1 HMS 2012-3724

- 1 enter into compliance agreements with the Oregon and Washington
- 2 departments of agriculture to monitor the growing and packing of
- 3 christmas trees to reduce the amount of invasive species that
- 4 may hitchhike with shipments to Hawaii.
- 5 For export, Hawaii's fruits industry, valued at
- 6 \$30,000,000; vegetable industry, valued at \$75,000,000; and
- 7 floral and nursery industry, valued at \$100,000,000, are at risk
- 8 of losing export markets due to quarantine measures imposed by
- 9 the federal government and other states. To assist the
- 10 agricultural industry, the legislature recommends that the
- 11 Hawaii department of agriculture enter into compliance
- 12 agreements with receiving states to establish origin-inspection
- 13 programs to ease quarantine restrictions placed on Hawaii's
- 14 growers.
- 15 The purpose of this Act is to authorize the department of
- 16 agriculture to establish, maintain, and enforce compliance
- 17 agreements with federal or state departments of agriculture as
- 18 to the import and export of plant commodities, and to assess
- 19 fees for conducting inspections required under compliance
- 20 agreements.
- 21 SECTION 2. Section 141-2, Hawaii Revised Statutes, is
- 22 amended to read as follows:

- 1 "S141-2 Rules. Subject to chapter 91, the department of
- 2 agriculture shall adopt, amend, and repeal rules not
- 3 inconsistent with law, for and concerning:
- 4 (1) The introduction, transportation, and propagation of trees, shrubs, herbs, and other plants;
- The quarantine, inspection, fumigation, disinfection, 6 (2) destruction, or exclusion, either upon introduction 7 into the State, or at any time or place within the State, of any nursery-stock, tree, shrub, herb, vine, 10 cut-flower, cutting, graft, scion, bud, seed, leaf, root, or rhizome; any nut, fruit, or vegetable; any 11 grain, cereal, or legume in the natural or raw state; 12 any moss, hay, straw, dry-grass, or other forage; any 13 14 unmanufactured log, limb, or timber; or any other plant growth or plant product unprocessed or in the 15 raw state; any sand, soil, or earth; any live bird, 16 reptile, insect, or other animal, in any stage of 17 18 development, that is in addition to the so-called domestic animals, which are provided for in section 19 142-2; and any box, barrel, crate, or other containers 20 in which the articles, substances, or objects have 21 22 been transported or contained, and any packing

	material used in connection therewith, that is or may
	be diseased or infested with insects or likely to
	assist in the transmission or dissemination of any
	insect or plant disease injurious, harmful, or
	detrimental, or likely to become injurious, harmful,

	industries or the forests of the State, or that is or
	may be in itself injurious, harmful, or detrimental to
	the same [+]; provided that included therein may be
	rules governing the transportation of any of the

(3)	The prohibition of importation into the State, from
	any or all foreign countries or from other parts of
	the United States, or the shipment from one island
	within the State to another island therein, or the
	transportation from one part or locality of any island
•	to another part or locality of the same island, of any
	specific article, substance, or object or class of
	articles, substances, or objects, among those
	enumerated above in this section, that is disposed or

2		transmission or dissemination of any insect or plant
3		disease injurious, harmful, or detrimental or likely
4		to be injurious, harmful, or detrimental to the
5		agricultural or horticultural industries, or the
6		forests of the State, or that is or may be in itself
7		injurious, harmful, or detrimental to the same;
8	(4)	The preparation by cargo carriers of manifests of
9		cargo transported into the State or between islands of
10		the State and the submission of the manifests to the
11		department; [and]
12	(5)	The establishment, maintenance, and enforcement of
13		compliance agreements with federal or state
14		departments of agriculture authorizing agriculture
15		inspectors from the state of origin in the case of
16		imports to the State, or State agricultural inspectors
17		in the case of State exports, to monitor the growing
18		and packing of plant commodities and any treatment
19		procedures to ensure compliance with quarantine laws,
20		and further authorizing the assessment of fees for
21		conducting inspections required under the compliance
22		agreement; and

1	$\left[\frac{(5)}{(5)}\right]$ The manner in which agricultural product
2	promotion and research activities may be undertaken,
3	after coordinating with the agribusiness development
4	corporation.
5	All rules adopted under this section shall have the force
6	and effect of law."
7	SECTION 3. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 4. This Act shall take effect upon its approval.
