A BILL FOR AN ACT

RELATING TO THE HOMELESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that despite efforts by 2 government and nonprofit organizations to provide overnight shelters for homeless persons, many homeless persons do not 3 4 sleep at the overnight shelters because of mental illness, drug 5 addiction, an inability to conform to shelter rules, or other 6 reasons. As a result, a large number of homeless persons can be found sleeping in public parks, on sidewalks, and similar areas, 7 8 raising concerns not only for health and safety issues but also 9 for the viability of the State's visitor industry. 10 The purpose of this Act is to appropriate funds to establish a safe haven program to provide overnight shelters for 11 12 homeless persons in designated surplus or available open or 13 vacant locations owned by the State. 14 There is appropriated out of the general SECTION 2. 15 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2012-2013 to 16

establish safe havens for homeless persons in surplus or

- 7 report to the legislature summarizing the safe haven program,
- 8 results achieved, actual expenditures, and recommended
- 9 legislation, if any, no less than twenty days prior to the
- 10 convening of the regular session of 2015.
- 11 SECTION 4. This Act shall take effect on July 1, 2012, and
- 12 shall be repealed on June 30, 2015.
