## A BILL FOR AN ACT

RELATING TO VOG.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Act 229, Session Laws of Hawaii 2011, is  
2 amended by amending subsection (d) of section 1 to read as  
3 follows:

4           "(d) The administrator of the civil defense agency of the  
5 county with an active volcano from which vog emanates shall be  
6 the chair of the interagency task force on vog. The task force  
7 shall include the following members or their designees:

8           (1) The director of health, or the director's designee;

9           (2) The vice director of civil defense, department of  
10 defense;

11           (3) The representative of the fourth representative  
12 district;

13           (4) The representative of the fifth representative  
14 district;

15           (5) The senator of the second senatorial district;

16           (6) Hawaii county council members representing lower Puna  
17 and Kau;

18           (7) The fire chief of the Hawaii county fire department;



- 1           (8) A representative from the Hawaii district office of
- 2                   the department of education;
- 3           (9) The chairperson of the east Hawaii regional board of
- 4                   the Hawaii health systems corporation;
- 5           (10) The chairperson of the board of agriculture;
- 6           (11) The chairperson of the board of land and natural
- 7                   resources;
- 8           (12) The district health officer for the Hawaii district
- 9                   health office of the department of health;
- 10          (13) The administrator of Kau hospital;
- 11          (14) The executive director of the Hawaii Visitors and
- 12                   Convention Bureau for the island of Hawaii; [~~and~~]
- 13          (15) The Hawaii district manager of the state department of
- 14                   transportation highways division[-];
- 15          (16) Any other representative from a representative
- 16                   district that is impacted by vog, as may be appointed
- 17                   by the speaker of the house of representatives at the
- 18                   speaker's discretion; and
- 19          (17) Any other senator from a senatorial district that is
- 20                   impacted by vog, as may be appointed by the president
- 21                   of the senate at the president's discretion.



1           The members of the task force shall serve without  
 2 compensation, and all necessary expenses, including travel  
 3 expenses, shall be paid by the agency, organization, or  
 4 department to which the member belongs."

5           SECTION 2. Statutory material to be repealed is bracketed  
 6 and stricken. New statutory material is underscored.

7           SECTION 3. This Act shall take effect upon its approval.
