A BILL FOR AN ACT

RELATING TO HAWAIIAN LANGUAGE IMMERSION PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that article X, section
- 2 4, of the state constitution provides, in relevant part, that:
- 3 "The State shall promote the study of Hawaiian culture,
- 4 history and language.
- 5 The State shall provide for a Hawaiian education program
- 6 consisting of language, culture and history in the public
- 7 schools."
- 8 The purpose of this Act is to further the purposes of
- 9 article X, section 4, of the state constitution, by requiring
- 10 that \$ of the total receipts from the public trust lands
- 11 that all departments and agencies reported receiving annually be
- 12 expended to fund Hawaiian language immersion programs in this
- 13 State.
- 14 SECTION 2. Chapter 10, Hawaii Revised Statutes, is amended
- 15 by adding two new sections to be appropriately designated and to
- 16 read as follows:
- 17 "§10- Hawaiian language immersion program grant
- 18 commission; established. (a) There is established a Hawaiian

- 1 language immersion program grant commission within the office of
- 2 Hawaiian affairs for administrative purposes.
- 3 (b) The commission shall consist of five members appointed
- 4 by the governor. Four of the members shall be selected as
- 5 follows:
- 6 (1) One from a list of not less than three names submitted
- 7 by the president of the senate;
- 8 (2) One from a list of not less than three names submitted
- 9 by the speaker of the house of representatives;
- 10 (3) One from a list of not less than three names submitted
- 11 by the office of Hawaiian affairs; and
- 12 (4) One from a list of not less than three names submitted
- by the Hawaiian homes commission.
- 14 (c) The members of the commission shall serve without
- 15 compensation, but shall be reimbursed for expenses necessary in
- 16 the performance of their duties. The members of the commission
- 17 shall be subject to section 26-34. The commission shall select
- 18 a chairperson from among its members.
- 19 (d) The commission shall submit to the legislature, no
- 20 later than twenty days prior to the convening of the regular
- 21 session of 2013, and every year thereafter, a report of its
- 22 grants, activities, findings, and recommendations.

- 1 (e) The commission, without regard to chapter 76, may 2 appoint and terminate an executive director and other additional 3 personnel as are necessary to enable the commission to perform the duties of the commission. The commission may fix the 4 5 compensation of the executive director and other commission 6 personnel. 7 Hawaiian language immersion programs grants. (a) §10-8 The Hawaiian language program grant commission shall have the 9 power to award grants to state agencies, individuals, and 10 private organizations, to further, assist, and support the 11 State's Hawaiian language immersion programs. All awards to 12 individuals and private organizations shall be made in 13 accordance with the standards provided in section 10-17, provided that for purposes of such awards, every reference in 14 section 10-17 to "office" shall instead be a reference to the 15 16 commission. **17** (b) All grants shall be made from an appropriation equal 18 to \$ of the total receipts from the public trust lands 19 that all departments and agencies reported receiving in the 20 immediately preceding fiscal year, pursuant to Act 178, Session 21 Laws of Hawaii 2006. - 2 providing for the office of Hawaiian affairs' portion of the
- 3 income and proceeds from the public trust lands, pursuant to

- 5 SECTION 3. New statutory material is underscored.
- 6 SECTION 4. This Act shall take effect upon its approval.
