A BILL FOR AN ACT

RELATING TO PROSTITUTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The purpose of this Act is to authorize a

 person convicted of committing the offense of prostitution to

 file a motion to vacate the judgment under certain circumstances

 and to establish procedures for the motion to vacate.

 SECTION 2. Chapter 712, Hawaii Revised Statutes, is
- $oldsymbol{6}$ amended by adding a new section to be appropriately designated
- 7 and to read as follows:
- 8 "§712- Prostitution; motion to vacate judgment. (1) A
- 9 person convicted of committing the offense of prostitution under
- 10 section 712-1200, loitering for the purpose of engaging in or
- 11 advancing prostitution under section 712-1206, street
- 12 solicitation of prostitution in designated areas under section
- 13 712-1207, or convicted of a lesser offense when originally
- 14 charged with a violation of section 712-1200, 712-1206, or 712-
- 15 1207, may file a motion to vacate the conviction if the
- 16 defendant's participation in the offense was the result of the
- 17 person having been a victim of:

4	<u>(b)</u>	A severe form of trafficking in persons as defined in

- 2 without a hearing if the court finds that the motion fails to
- 3 assert grounds on which relief may be granted.
- 4 (4) Official documentation of the defendant's status as a
- 5 victim of trafficking or a victim of a severe form of
- 6 trafficking from a federal, state, or local government agency or
- 7 a sworn statement from a trained professional staff member of a
- 8 victim services organization, an attorney, a member of the
- 9 clergy, or a medical or other health professional from whom the
- 10 defendant has sought services to address the effects of having
- 11 been trafficked shall create a presumption that the person's
- 12 participation in the offense of prostitution was a result of
- 13 having been a victim of trafficking or a victim of a severe form
- 14 of trafficking, but shall not be required for granting a
- 15 petition under this subsection.
- 16 (5) If the court grants a motion filed under this section,
- 17 the court shall vacate the conviction and dismiss the accusatory
- 18 pleading, and may take additional action as is appropriate in
- 19 the circumstances or as justice requires.
- 20 (6) A person making a motion to vacate pursuant to this
- 21 section has the burden of proof by a preponderance of the
