A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. The legislature finds that temporary exemptions
3	are necessary to expedite the construction and improvement of
4	public housing units and public infrastructure. Temporary
5	exemptions achieve the dual benefits of promoting jobs in the
6	local economy and developing valuable public assets. The repair
7	and maintenance of vacant public housing units should reduce the
8	turnaround time between vacating and incoming tenants, thereby
9	resulting in an increase in the affordable housing inventory.
10	The purpose of this part is to address economic
11	revitalization. Specifically, this part temporarily exempts the
12	following from the state and county civil service:
13	(1) Persons hired or contracted to repair and maintain
14	vacant public housing units; and
15	(2) Persons hired or contracted to perform planning,
16	design, engineering, or permit processing work for
17	state or county capital improvement projects.

1	SECT	ION 2. Section 46-33, Hawaii Revised Statutes, is
2	amended t	to read as follows:

11		piecework basis by persons who may lawfully perform
12		their duties concurrently with their private business

(b) The director of the public agency employing an employee subject to subsection (a) shall determine whether to terminate or retain an employee subject to this Act; provided that if the employee is to be retained, all costs associated with retaining the employee shall be covered by the public agency's existing budget.

13 The legislature finds that many public housing SECTION 6. 14 projects in the State are in poor condition. During the 2010 **15** federal inspections for housing projects last year, eleven out 16 of the sixty-five federal housing projects failed to pass **17** inspection, receiving a score of fifty-nine or below out of a 18 possible one hundred. Approximately one-third of the housing 19 projects received a score of sixty-nine or below. To address 20 the host of problems plaguing public housing, the Hawaii public 21 housing authority recently embarked on a major turnaround plan 22 that involves revamping vacant units, streamlining how

- 1 applications are processed, and encouraging a fast turnaround
- 2 for filling vacancies. In recent reports, as many as four
- 3 hundred to six hundred units are not being rented due to
- 4 uninhabitable conditions. According to a 2003 assessment at
- 5 Kuhio park terrace, the largest and one of the oldest public
- 6 housing projects in Hawaii, the estimated capital improvement
- 7 cost would be approximately \$63,000,000.
- 8 The legislature also finds that in addition to increasing
- 9 problems in public housing, high unemployment in the
- 10 construction and trade industry exacerbates economic problems
- 11 for individuals that are within the low- to moderate-income
- 12 population, which is commonly referred to as the "gap group",
- 13 and includes individuals with gross incomes that fall between
- 14 one hundred twenty-five per cent and two hundred fifty per cent
- 15 of federal poverty guidelines. This population is especially
- 16 vulnerable to becoming homeless if adequate, habitable, and
- 17 affordable housing is unavailable.
- 18 The purpose of this part is to provide funding to improve
- 19 the public housing inventory in the State.
- 20 SECTION 7. The director of finance is authorized to issue
- 21 general obligation bonds in the sum of \$ or so much
- 22 thereof as may be necessary and the same sum or so much thereof

- 1 as may be necessary is appropriated for fiscal year 2012-2013 to
- 2 renovate public housing units that are uninhabitable.
- 3 SECTION 8. The sum appropriated under section 7 shall be
- 4 expended by the Hawaii public housing authority for the purposes
- 5 of this part.
- 6 SECTION 9. The appropriation made for capital improvement
- 7 projects authorized by this part shall not lapse at the end of
- 8 the fiscal biennium for which the appropriation is made;
- 9 provided that all moneys from the appropriation unencumbered as
- 10 of June 30, 2014, shall lapse as of that date.
- 11 SECTION 10. Notwithstanding any law to the contrary,
- 12 capital improvement projects executed under this part shall be
- 13 exempt from the contest provisions of chapter 103D, Hawaii
- 14 Revised Statutes.
- 15 PART III
- 16 SECTION 11. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 12. This Act shall take effect on July 1, 2030;
- 19 provided that part I of this Act shall be repealed on July 1,
- 20 2015, and sections 46-33, 76-16(b), and 76-77, Hawaii Revised

- 1 Statutes, shall be reenacted in the form in which they read on
- 2 the day before the effective date of this Act.

Temporary Civil Service Exemption; Hawaii Public Housing Authority; Appropriation

Description:

Exempts temporarily from the state and county civil service: (1) persons hired or contracted to repair and maintain vacant state or county housing units; and (2) persons hired or contracted to perform planning, design, engineering, or permit processing work for state or county capital improvement projects. Appropriates an unspecified dollar amount out of general obligation bonds to the Hawaii public housing authority for renovating uninhabitable public housing units. Effective July 1, 2030. (HB2302 HD2)
