
A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the education of
2 Hawaii's students is imperative not only for each student's
3 future success, but for the overall strength of Hawaii's economy
4 and communities. However, a student's education suffers if that
5 student does not attend school each day. Some schools in the
6 State report more than fifteen per cent of students in the
7 school miss fifteen or more school days in a year.

8 The legislature further finds that there are many reasons a
9 student may miss school, including sickness, the care of a
10 sibling or parent, or the assumption that school simply isn't
11 important. In order to develop comprehensive solutions that
12 address the underlying causes of school absenteeism, it is
13 important to consider the issue from a broad perspective and
14 within an appropriate context.

15 The purpose of this Act, therefore, is to establish a
16 school attendance working group that brings together knowledge
17 from several government agencies and community organizations to
18 address this growing concern.



1 SECTION 2. (a) The department of education shall
2 establish a school attendance working group to consist of the
3 following members:

4 (1) The chair of the board of education or the chair's
5 designee;

6 (2) The superintendent of education or the
7 superintendent's designee;

8 (3) The presiding judge of the family court of the first
9 circuit or the presiding judge's designee;

10 (4) The chief of police of the Honolulu police department
11 or the chief's designee;

12 (5) A county prosecutor, to be appointed by the governor;

13 (6) A high school principal, to be appointed by the
14 superintendent of education;

15 (7) A department of education counselor, to be appointed
16 by the superintendent of education;

17 (8) A high school student, to be appointed by the
18 superintendent of education;

19 (9) A public member with relevant expertise to be
20 appointed by the speaker of the house of
21 representatives; and



- 1 (10) A public member with relevant expertise to be
2 appointed by the president of the senate.
- 3 (b) The working group established in subsection (a) shall:
- 4 (1) Collect attendance data from each school;
- 5 (2) Collect truancy data from law enforcement and the
6 judiciary;
- 7 (3) Discover and analyze causes for absenteeism among K-12
8 students;
- 9 (4) Devise policies to address:
- 10 (A) Student attendance tracking;
- 11 (B) Parental notification;
- 12 (C) Chronic absenteeism; and
- 13 (D) Truancy; and
- 14 (5) Make recommendations to the board of education,
15 department of education, governor, and legislature
16 regarding policies and actions to increase student
17 attendance and reduce high absentee rates.
- 18 (c) Members of the working group shall not be entitled to
19 compensation but shall be reimbursed for necessary travel
20 expenses incurred in the performance of their duties on the
21 working group.



1 (d) No member shall be made subject to chapter 84, Hawaii
2 Revised Statutes, solely because of that member's participation
3 as a member of the working group.

4 (e) The working group shall submit a report of its
5 findings, including any recommendations for legislation, no
6 later than twenty days prior to the convening of the regular
7 session of 2013.


8 SECTION 3. There is appropriated out of the general
9 revenues of the State of Hawaii the sum of \$5,000 or so much
10 thereof as may be necessary for fiscal year 2012-2013 for the
11 working group to accomplish the purposes of this Act.

12 The sum appropriated shall be expended by the department of
13 education for the purposes of this Act.

14 SECTION 4. This Act shall take effect on July 1, 2012.
