BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Purpose. There are five voting members

DEPARTMENT: Business, Economic Development, and Tourism

TITLE:	A BILL FOR AN ACT RELATING TO THE HAWAII COMMUNITY DEVELOPMENT AUTHORITY.
PURPOSE:	Permit the Authority's Kalaeloa Community Development District ex-officio members to designate a representative with voting- powers at an authority meeting.
MEANS:	Amend section 206E-191(c), Hawaii Revised Statutes.
JUSTIFICATION:	Currently, section 206E-191 does not provide specific authorization to the Chairperson of the Hawaiian Homes Commission of the Department of Hawaiian Home Lands and the Director of the City and County of Honolulu Department of Planning and Permitting to designate a person with voting powers to attend an Authority meeting on his/her behalf. The statute should be amended to permit such designation with voting powers to be in congruence with the abilities of the Kakaako Community Development District ex-officio members to do the same.
	Impact on the public: This amendment will allow the Authority greater flexibility in achieving quorum for its Authority meetings when it is tasked with making decisions on matters affecting the Kalaeloa Community Development District.
	Impact on the department and other agencies: This amendment will provide the Department of Hawaiian Home Lands and the City Department of Planning and Permitting the option to assign a designee to attend the Authority meeting and have voting powers in order to ensure representation and participation of these agencies.
