#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

#### JUSTIFICATION SHEET

DEPARTMENT: Human Services

TITLE: A BILL FOR AN ACT RELATING TO EXEMPTIONS FROM CHILD CARE LICENSING.

PURPOSE: Adds exemptions for any kindergarten, school, or program licensed by the Charter School Review Panel, the Hawaii Council of Private Schools, or any federal agency from child care licensing by the Department of Human Services.

- MEANS: Amend section 346-152(a), Hawaii Revised Statutes.
- JUSTIFICATION: Kindergartens, schools, or child care programs to be exempted are already licensed by the Charter School Review Panel, the Hawaii Council of Private Schools, or federal agencies which administer them. There is no reason for the department to also license these already-licensed kindergartens, schools and child care programs.

Impact on the public: None.

Impact on the department and other agencies: Gives the department the authority to exempt kindergartens, schools, and programs already being licensed by other agencies.
